## INTRODUCTION

Floods can happen anywhere, anytime. Major storms, like hurricanes, are not the only causes of flooding. Most floods are too small or local to qualify for relief assistance. You do not have to live near water or in a flood zone to become flooded. In fact, approximately 30% of flood insurance claims come from areas outside of the 100-year floodplain and are designated as low-risk.

Not all insurance policies cover flood damages. Losses due to flooding **are not** covered under typical homeowner's and business owner's insurance policies. A separate insurance policy for flooding is needed. Flood insurance is available through the National Flood Insurance Program (NFIP) administered by the Federal Emergency Management Agency (FEMA). If you live in a community that participates in the NFIP, flood insurance is available. The NFIP, in conjunction with property or casualty insurance agents, brokers or with most of the country's major insurance companies and independent insurance agents, offers flood insurance to individuals and businesses located within NFIP participating communities throughout the United States. Flood insurance provides coverage for damages to structures, contents, flood-related erosion and other types of flood-caused damages. Whether you are a renter or own your home (including condominiums) or business, you can purchase flood insurance.

A community that participates in the NFIP must comply with FEMA's minimum standards for floodplain management. For those communities that do, the NFIP created the Community Rating System (CRS) program. The CRS is a voluntary program that recognizes community efforts that go above and beyond the minimum standards established in the NFIP by reducing flood insurance premiums for renters and property owners.

A community that chooses to participate in the Community Rating System determines which of the 18 public information and floodplain management activities to perform. Each participating community assigns a CRS Coordinator who is responsible for the CRS program application and to make sure that the community performs the activities chosen.

## PURPOSE

Many areas of Pinellas County can be considered low-lying or subject to flooding. Therefore, **unincorporated** Pinellas County and most of the communities within the County participate in the National Flood Insurance Program and the Community Rating System. This document was created to provide contacts within the jurisdictions who can answer questions regarding flooding, the CRS program, flood and evacuation zones, flood hazards, and flood protection. In addition, these people can increase your awareness of the hazards of flooding, mitigating the effects from flooding and flood damage, and to assist with flood protection.

The following directories identify the contact(s) in the jurisdictions throughout Pinellas County. Additionally, contacts are listed for the surrounding counties, State governmental agencies and Federal government for further information and requests for flood related materials such as publications and maps. For convenience, website addresses are listed for those jurisdictions and other governmental agencies that have created webpages and links to various departments and staff, or provide flood-related or mitigation information.

## **TROPICAL CYCLONES**

A tropical cyclone is a warm-core, non-frontal low pressure system which exhibits synchronized characteristics on a large scale. The storm develops over tropical or subtropical waters and has a definite organized surface circulation. The term tropical cyclone is a generic phrase, which covers tropical disturbances, tropical depressions, tropical storms, and hurricanes.

Tropical cyclones are unpredictable. Although the Tampa Bay area is considered a vulnerable location, the area has not received a direct hit from a major hurricane since 1921. However, that doesn't mean that Pinellas County hasn't been hit by hurricanes. In 1848 the County was hit by two major hurricanes that were within a month from one another. The first occurred on September 25th. The storm's track was northerly along the west coast of Florida with the eye slightly offshore. Storm surge was estimated at 15 feet. The effects of the storm created Stump Pass, Casey's Pass, New Pass and Longboat Inlet to the south of the Tampa Bay area. Locally, all barrier islands were inundated. The Egmont Key lighthouse, which at the time was the first and stood at 120 feet tall and was made of concrete and brick, was undermined which led to the construction of the lighthouse currently on the island. Shell Key, Summer Resort Key and other smaller barrier islands were altered. The North Channel at Pass-A-Grill and South Channel, south of Shell Key was altered. Tierra Verde was split, forming two islands. John's Pass was created during this storm. Then about three weeks later, the second major hurricane hit. On October 16, 1848, the hurricane hit the Pinellas County area with a storm surge of about 12 feet. Again, all of the barrier islands, including Egmont Key were completely inundated. The hurricane greatly affected a hog farm on Sand Island, later changed to Hog Island, which later became Honeymoon Island (today).

In 1985, Hurricane Elena, a Category 3 hurricane, spun 90 miles offshore of Pinellas over Labor Day Weekend. As it looped offshore, Elena sent high winds, rain and heavy surf that created a 7-foot tidal surge and severe erosion along the beaches. Mandatory evacuations were issued. Then in March, 1993, a winter "Storm of the Century" hit the County with high winds, rain and a tidal surge that flooded low-lying areas. Tropical Storm Josephine came by in 1996 with a high storm surge that also flooded the low-lying areas of the County. Tropical Storm Harvey, 1999, was headed straight for Tampa Bay from the Gulf when it took a sudden turn to the south during the night and made landfall in the Ft. Myers/Naples area. In 2000, Hurricane Georges was sliding up the west coast of the State as a Category 2 hurricane. The track, however, changed from north to the Tampa Bay area to northwest, which kept the storm from creating serious flooding and damages to Pinellas County. This was the last storm where the County issued an evacuation of Level "A" areas until 2004.

The 2004 Hurricane Season was an unprecedented season for Florida as we were hit with 4 major hurricanes (Charley, Frances, Ivan, and Jeanne), three of which affected the Tampa Bay area over the span of six weeks. Pinellas County received a Presidential Disaster Declaration for two of those hurricanes, Frances and Jeanne. As a Category 3 and 4 storm, Hurricane Charley was on track to make landfall in Tampa Bay (with less than 6 hours to landfall), but took a right turn and made landfall in Charlotte County. Frances and Jeanne did the greatest damages within Pinellas County from heavy rains and tropical force winds even though these were exiting storms. Mandatory Hurricane Evacuation Levels "A-C" were called for Hurricane Charley and Level "A" for Hurricanes Frances and Jeanne.

History teaches that a lack of hurricane awareness and preparation are common threads among all major hurricane disasters. By knowing your vulnerability and what actions you should take, you can reduce the effects of a hurricane disaster. This Flood Information Reference Guide serves as a tool for you in preparing

for a hurricane and for mitigating the effects from tropical cyclones and heavy rain or weather events such as flooding and wind damage.

**Hurricanes and Typhoons:**

Both hurricanes and typhoons are warm-core tropical cyclones in which the maximum sustained surface wind is 74 miles per hour (64 knots) or more. Hurricanes are found in the Atlantic Ocean and eastern Pacific Ocean. A typhoon is a hurricane on the other side of the International Dateline.

**The Saffir-Simpson Hurricane Scale:**

The Saffir-Simpson Hurricane Scale is a 1-5 rating based on the hurricane's present intensity. This is used to give an estimate of the potential property damage and flooding expected along the coast from a hurricane landfall. Wind speed is the determining factor in the scale, as storm surge values are highly dependent on the slope of the continental shelf in the landfall region. For the purposes of this Scale, all winds were measured using the U.S. 1-minute average, meaning that the winds speeds are measured and averaged over a period of one minute. The following table incorporates the Saffir-Simpson Hurricane Scale to compare each of the tropical cyclones and the possible damages expected as a result of the increasingly intensity of a storm.

Flooding will occur from wind-driven waters and the rising waters from the hurricane storm surge. A storm surge is an abnormal rise in sea level 50 to 100 miles wide that sweeps across the coast near where the eye of accompanying a hurricane or other intense storm makes landfall. The storm surge height is measured as the difference between the observed level of the sea surface during the storm and the level that would have occurred in the absence of the tropical cyclone. Storm surge is usually estimated by subtracting the normal or astronomic tide from the observed storm tide. In addition, waves on top of the storm surge will create an even greater high-water mark and increase the storm's devastation. Therefore, the storm surge is the greatest threat to life and property. Most hurricane-related deaths are caused by drowning.

Coastal flooding from tropical cyclones is not the only destructive flood waters. Tropical cyclones can produce widespread torrential rains often in excess of ten inches in a relatively short period of time. A nearly stationary or slow moving storm will bring in very heavy rains which are capable of producing destructive floods. These floods can be a major threat to areas that are not only considered to be coastal, but also areas that are well inland.
