SUBJECT: Appointments to the Charter Review Commission (CRC)

The Pinellas County Charter requires that every six years the Pinellas County Board of County Commission (Board) establish a Charter Review Commission (CRC) composed of thirteen (13) members representing the following groups:

- One (1) member from the Pinellas County Legislative Delegation residing in Pinellas County;
- One (1) constitutional officer;
- One (1) member from the elected city officials;
- One (1) member from the elected board of county commissioners'
- Nine (9) members from the public at large, none of whom shall be an elected official.

The Charter also directs the Board to appoint the members of the CRC during the month of December. Since an Orientation Session is scheduled for Monday, December 7th, it is necessary for the Board to appoint the CRC at its December 1st meeting.

Per the Board's directives at its September 22, 2009 meeting, each Board member individually selected its public-at-large designee. The remaining two positions will be selected by the Board as a whole, as well as other specified categories. Correspondence was sent by the Chairman to the Pinellas County Legislative Delegation, the Constitutional Officers, all municipal elected officials, major neighborhood organizations, the chambers of commerce, and civic organizations. Interested persons were asked to submit a letter of interest and a resume. See the attached chart for potential members.

The Constitutional Officers have unanimously recommended that Diane Nelson, Tax Collector serve as their representative on the CRC. For the remaining specified categories, you have the following persons (listed alphabetically by their surnames) willing to serve.

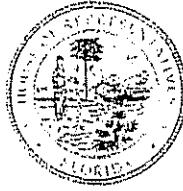

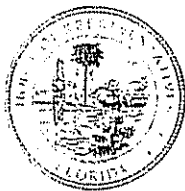

Ms. Bandoni, President of Turnstone Properties, Inc. has been responsible for facilitating the development of affordable housing and community development throughout the Tampa Bay Area for the past twenty years. 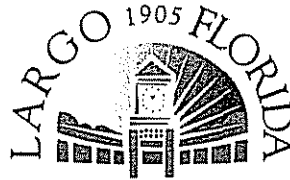




