**ORDINANCE NO. 2012-17**

**AN ORDINANCE OF THE CITY OF SAFETY HARBOR, FLORIDA, ANNEXING CERTAIN PROPERTY LOCATED IN SONIA TERRACE, PINELLAS COUNTY, FLORIDA AND MORE PARTICULARLY DESCRIBED BELOW INTO THE CORPORATE LIMITS OF THE CITY OF SAFETY HARBOR, FLORIDA, UPON THE PASSAGE OF THIS ORDINANCE; AND PROVIDING FOR PUBLICATION IN ACCORDANCE WITH LAW.**

**WHEREAS**, the City of Safety Harbor, Florida, has been petitioned by the owners to annex certain described lands, which are reasonably compact, lying contiguous to the territorial limits of said City, and

**WHEREAS**, said petition was accompanied by all proper documentation certifying the titleholders to said property; and

**WHEREAS**, the City Commission has determined that the petition bears the signatures of all owners of property in the area proposed to be annexed.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF SAFETY HARBOR, FLORIDA, that:**

1. The City of Safety Harbor, Florida, acting by and through its City Commission, by the authority of the provisions of the Charter of the City of Safety Harbor, Florida, hereby annexes into the corporate limits of the City of Safety Harbor, the property described as:

Lots 1, 2, & 3 and East 1/2 of Vacated 14th Avenue Adjacent on West of Block 1, SONIA TERRACE, as recorded in Plat Book 19, Page 34, of the Public Records of Pinellas County, Florida.


2. The City of Safety Harbor, Florida hereby redefines the boundary lines of said City as to include the property hereinabove described.
3. The territory so annexed into the City of Safety Harbor, Florida, and the inhabitants thereof, shall enjoy all of the privileges and be subject to all of the

liabilities as set forth in Chapter 171, Florida Statutes, or amendments thereto, as are applicable to the other lands and inhabitants within the corporate limits and subject to all laws and ordinances of the City of Safety Harbor.


4. The City Clerk, or her designee, is hereby directed to file this Ordinance, together with a map which clearly shows the annexed area and a complete legal description, with the clerk of the circuit court and the chief administrative officer of Pinellas County and the Department of State within seven (7) days of the date of adoption.
4. This Ordinance shall become effective immediately upon its passage and adoption.
5. This Ordinance shall be published in accordance with the requirements of law.






