The City of Clearwater, Florida, proposes to adopt the following ordinances:

### ORDINANCE NO. 8374-13

AN ORDINANCE OF THE CITY OF CLEARWATER, FLORIDA, ANNEXING CERTAIN REAL PROPERTY LOCATED ON PART OF SUNSET POINT ROAD RIGHT OF WAY AND HERCULES AVENUE RIGHT OF WAY, CONSISTING OF A PORTION OF SECTION 1, TOWNSHIP 29 SOUTH, RANGE 15 EAST, ABUTTING REAL PROPERTY, WHOSE POST OFFICE ADDRESS IS 1990 SUNSET POINT ROAD, INTO THE CORPORATE LIMITS OF THE CITY, AND REDEFINING THE BOUNDARY LINES OF THE CITY TO INCLUDE SAID ADDITION; PROVIDING AN EFFECTIVE DATE.


