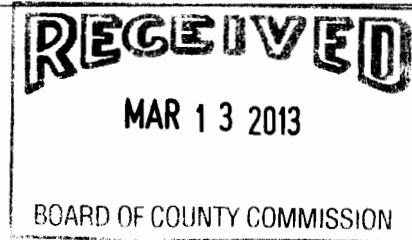

**A RESOLUTION OF THE CITY OF LARGO, FLORIDA REPEALING
RESOLUTION NO. 2080 REGARDING PRIORITY MEDICAL DISPATCH;
PROVIDING AN EFFECTIVE DATE.**

WHEREAS, on September 18, 2012 the City Commission adopted Resolution No. 2080 in support of medical priority dispatch in Pinellas County; and

WHEREAS, after further review of the proposed priority medical dispatch program the City Commission has determined it appropriate and in the best interest of its citizens not to support medical priority dispatch and to repeal Resolution No. 2080.

NOW, THEREFORE, THE CITY OF LARGO CITY COMMISSION HEREBY RESOLVES:

Section 1. That the City Commission does not support priority medical dispatch and that Resolution No. 2080 is hereby repealed in its entirety.

Section 2. That this resolution shall become effective immediately upon its adoption.


