SUBJECT: Adoption of Resolution Amending Resolution No. 12-81 to Add a Permit Fee
for the Administration of the Dog Friendly Dining Program

DATE: April 9, 2013

RECOMMENDATION: I RECOMMEND THAT THE BOARD OF COUNTY COMMISSIONERS ADOPT THE ATTACHED RESOLUTION AMENDING RESOLUTION NO. 12-81 TO ADD A PERMIT FEE FOR THE ADMINISTRATION OF THE DOG FRIENDLY DINING PROGRAM.

DISCUSSION: In conjunction with this request for adoption of the attached resolution, the Board was also presented earlier at this same meeting with the Dog Friendly Dining Ordinance for approval. If adopted, the Dog Friendly Dining Ordinance directs staff to administer the Dog Friendly Dining Program, which requires staff to review permit applications and seating plans, perform site inspections, and organize and forward the appropriate documentation to the State.

On September 6, 2012, the Board of County Commissioners ("Board") adopted Resolution No. 12-81, which established the schedule of fees for FY13 for Non-Proprietary Departments, the Airport, and the Department of Environment and Infrastructure-Utilities. It is within the Board's authority to amend Resolution No. 12-81 to add a recommended permit administration fee to recover the costs of administering the program if the ordinance is adopted. The proposed fee for FY13 is \$215.

RESOLUTION NO. 13-

RESOLUTION AMENDING THE SCHEDULE OF FEES ESTABLISHED IN RESOLUTION NO. 12-81 FOR NON-PROPRIETARY DEPARTMENTS, THE AIRPORT AND DEPARTMENT OF ENVIRONMENT AND INFRASTRUCTURE-UTILITIES; ADDING A PERMIT FEE FOR THE ADMINISTRATION OF THE DOG FRIENDLY DINING PROGRAM; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Pinellas County, Florida is empowered to set fees relating to the provision of services provided by Non-Proprietary Departments, the Airport, and the Department of Environment and Infrastructure-Utilities; and

WHEREAS, Resolution No. 12-81 established the schedule of fees for Non-Proprietary Departments, the Airport, and the Department of Environment and Infrastructure-Utilities for Fiscal Year 2013; and

WHEREAS, the Board of County Commissioners finds it necessary to amend Resolution No. 12-81.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Pinellas County, Florida, in regular session, duly assembled, this 9th day of April 2013, as follows:

- Section 1. Resolution No. 12-81 is hereby amended to add a permit fee to be charged by Building and Development Review Services for the administration of the Dog Friendly Dining Program, which is set out in Attachment 1, and is hereby adopted and approved.
- Section 2. Any provision in Resolution No. 12-81 that is not hereby amended shall remain in full force and effect.
- Section 3. This Resolution shall take effect on April 29, 2013.


