I RECOMMEND THE BOARD OF COUNTY COMMISSIONERS (BCC) ADOPT THIS RESOLUTION GRANTING APPROVAL OF THE PROPOSED REPLACEMENT OF NINETEEN (19) EXISTING 50W SEBRING POST TOP DECORATIVE LIGHTING FIXTURES ON 14' FIBERGLASS POLES WITH NINETEEN (19) 100W OCALA POST TOP DECORATIVE LIGHTING FIXTURES ON 16' COLONIAL CONCRETE POLES IN THE BARRINGTON OAKS WEST SUBDIVISION STREET LIGHTING DISTRICT, AS REQUESTED IN THE ATTACHED PETITION.

Summary Explanation/Background:

On June 4, 2013 the BCC authorized advertisement of a public hearing to be held on July 9, 2013 to consider a proposed Resolution for the replacement of fixtures in the Barrington Oaks West Subdivision Street Lighting District.

This item consists of the proposed replacement of nineteen (19) 50W decorative fixtures and poles with nineteen (19) 100W decorative fixtures and poles. The Barrington Oaks West Subdivision Street Lighting District consists of fifty-three (53) private property units. Fifty-One (51) of the residents were advised of the petition and approximately 79% (42) of the property owners have signed the petition to replace the fixtures in the district. Two (2) could not be contacted. All property owners within the district were sent notices of the hearing by first class United States mail.

Fiscal Impact/Cost/Revenue Summary:

The cost estimates provided by Duke Energy (formerly known as Progress Energy) are, Construction = \$4,219.03, and Monthly Service = \$438.33. Pinellas County administrative charges are estimated to be \$1,421.85, and the cost to advertise the public hearing is estimated to be \$275.00. For the first twelve (12) months, the Barrington Oaks West Subdivision Street Lighting District is estimated to cost \$11,175.84, and the cost to each property unit would be \$210.86. However, depending on when construction occurs, either the total construction cost or a pro-rated construction cost, in addition to the monthly service charges (inclusive of administrative and advertisement charges), will appear on the initial notice for tax payment. The balance of the construction cost, if any, will be included with the following year's service and administrative costs.

In the subsequent years, the annual recurring cost to each property owner is estimated to be \$114.13. The General Fund will be reimbursed from annual assessments on each property within the Barrington Oaks West Subdivision Street Lighting District.

RESOLUTION GRANTING APPROVAL FOR BARRINGTON OAKS WEST SUBDIVISION STREET LIGHTING DISTRICT TO REPLACE NINETEEN (19) EXISTING 50W SEBRING POST TOP DECORATIVE LIGHTING FIXTURES ON 14' FIBERGLASS POLES WITH NINETEEN (19) 100W OCALA POST TOP DECORATIVE LIGHTING FIXTURES ON 16' COLONIAL CONCRETE POLES; AUTHORIZE FUNDS FOR ADMINISTRATIVE EXPENSES DIRECTLY INCIDENTAL TO REPLACING INVENTORY IN SAID DISTRICT; AND AUTHORIZE COLLECTION OF EXPENSE REIMBURSEMENT BY AN INCREASE IN THE SPECIAL ASSESSMENT CURRENTLY LEVIED AND SHARED BY THE PROPERTY OWNERS WITHIN THE DISTRICT.

WHEREAS, a petition has been presented to the Board of County Commissioners "Board", Pinellas County, Florida, for proposed changes in lighting services in the Barrington Oaks West Subdivision Street Lighting District "District" within the unincorporated area of Pinellas County and within the boundaries described below:

Description of Barrington Oaks West Subdivision Street Lighting District:

The Barrington Oaks West Subdivision Street Lighting District shall embrace and be comprised of the following legally described real property:

Barrington Oaks West Subdivision, as recorded in Plat Book 85, Pages 72 & 73, public records of Pinellas County, Florida.

All of the above being located in Section 12, Township 28 South, Range 15 East, Pinellas County, Florida.

WHEREAS, the cost of said changes in lighting services in the Barrington Oaks West Subdivision Street Lighting District will exceed fifteen percent (15%) of the property owners' last assessment; and

WHEREAS, changes in lighting services that exceed fifteen percent (15%) of the property owners' last assessment requires a petition signed in excess of sixty percent (60%) of the property owners within said street lighting district pursuant to Pinellas County Resolution No. 90-304 (Aug. 28, 1990); and

WHEREAS, said petition has been signed by more than sixty percent (60%) of the owners within said street lighting district as described in said petition, as required in accordance with Pinellas County Resolution No. 90-304; and

WHEREAS, said petition provides, and the petitioners understand and agree, that the cost of replacing and maintaining the street lighting within the existing District will be funded by an increase in the special assessment currently levied to be equally shared by the owners of land within the District; and

WHEREAS, the County Department of Environment and Infrastructure (DEI) has reviewed the petition, together with the associated information, and estimated that the increase to the special assessment to be levied on all properties within the District appears reasonable, equitable and sufficient to pay for the cost of decorative street lighting upgrade; and

WHEREAS, funds needed to cover administrative and costs directly incidental to the changes in lighting services in the District will be collected by the County when the non-ad valorem assessment is collected by the uniform method of collection from each of the property owners within the district.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Pinellas County, Florida, duly assembled this ____ day of _____, 2013, that the petition proposing the changes in lighting services in said District is hereby approved; and

BE IT FURTHER RESOLVED, that Pinellas County be authorized to provide funds to pay for the administrative costs incurred to make changes in the lighting services in this existing District, said funds to be reimbursed by the District from the non-ad valorem assessment collected by the uniform method of collection.
