

ORDINANCE NO. 2013-15

AN ORDINANCE OF THE CITY OF SAFETY HARBOR, FLORIDA, ANNEXING CERTAIN PROPERTY LOCATED IN HARBOR HILLS PARK, PINELLAS COUNTY, FLORIDA AND MORE PARTICULARLY DESCRIBED BELOW INTO THE CORPORATE LIMITS OF THE CITY OF SAFETY HARBOR, FLORIDA, UPON THE PASSAGE OF THIS ORDINANCE; AND PROVIDING FOR PUBLICATION IN ACCORDANCE WITH LAW.

WHEREAS, the City of Safety Harbor, Florida, has been petitioned by the owner to annex certain described lands, which are reasonably compact, lying contiguous to the territorial limits of said City, and

WHEREAS, said petition was accompanied by all proper documentation certifying the titleholders to said property.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF SAFETY HARBOR, FLORIDA, that:

1. The City of Safety Harbor, Florida, acting by and through its City Commission, by the authority of the provisions of the Charter of the City of Safety Harbor, Florida, hereby annexes into the corporate limits of the City of Safety Harbor, the property described as:

Lot 77, Harbor Hills Park, according to the Map or Plat thereof, as recorded in Plat Book 8, Page 26, of the Public Records of Pinellas County, Florida.



2. The City of Safety Harbor, Florida hereby redefines the boundary lines of said City as to include the property hereinabove described.
3. The territory so annexed into the City of Safety Harbor, Florida, and the inhabitants thereof, shall enjoy all of the privileges and be subject to all of the liabilities as set forth in Chapter 171, Florida Statutes, or amendments thereto, as are applicable to the other lands and inhabitants within the corporate limits and subject to all laws and ordinances of the City of Safety Harbor.
4. This Ordinance shall become effective immediately upon its passage and adoption.
5. This Ordinance shall be published in accordance with the requirements of


law.


