Approval of Ranking of Consultant Selection - Professional Design Build Services- Belleair Causeway Bait House Contract No. 123-0328-NC(RM)

I RECOMMEND THE BOARD OF COUNTY COMMISSIONERS (BOARD) APPROVE THE RANKING OF FIRMS AND AUTHORIZE STAFF TO NEGOTIATE AN AGREEMENT WITH ONE OF THE FIRMS PRESENTED TO THE BOARD FOR CONSIDERATION TO PROVIDE PROFESSIONAL DESIGN BUILD SERVICES FOR THE BELLEAIR CAUSEWAY BAIT HOUSE.

Summary Explanation/Background:

On July 26, 2013, the Purchasing Department on behalf of the Department of Real Estate Management (REM) released a Request for Proposal (RFP) for the intent of obtaining the services of a qualified design build firm to provide the design and construction of a new bait house that will be located adjacent to the Belleair Causeway Bridge. More specifically, the building will be constructed on an elevated deck system and will be designed to allow for private concessionaire space. The concessionaire, which will be selected through a separate competitive process, will be required to install their own equipment and furnishings.

Proposals were received from the following firms:

1. Bandes Construction Company, Inc.
2. Caladesi Construction Company
3. Cutler Associates, Inc.

An evaluation committee (committee) consisting of two (2) representatives from the Real Estate Management Department (REM) Design and Construction Division, one (1) representative from REM Fleet Division and two (2) representatives from the Department of Environment & Infrastructure (DEI) along with a representative from the Purchasing Department acting as a facilitator, met on September 24, 2013, to evaluate and score the proposals received. The two (2) highest ranked firms were then invited to the oral presentation process.

On October 14, 2013 oral presentations were presented by the two (2) highest ranked firms. The final ranking of firms by the committee is as follows:

1. Caladesi Construction Company (Caladesi) 923 Points
2. Cutler Associates, Inc. (Cutler) 923 Points

After the evaluation and scoring of oral presentations was complete and a tie score was apparent, the committee thoroughly reviewed the scores of both firms and concluded that each firm has the required experience and qualifications to meet project requirements. The committee recommended that staff present a summary of the scores received by the two firms and present the Board with a method to break the tie and seek Board guidance for proceeding with negotiations. It should be noted that this evaluation process was conducted under the former CCNA evaluation procedure where the oral presentation process was solely utilized as the method for ranking recommendation.

At the November 5, 2013 Board Meeting, the Purchasing Director provided a report and recommendations to improve the CCNA evaluation process. One of the recommendations was to carry scores forward from the written evaluation process and combine the scores with the oral presentation evaluation to achieve one total score. It was suggested this approach would reduce the potential of a tie score. By applying this recommendation to the tie oral evaluation score, Cutler would be the apparent number one ranked firm.

Caladesi	742 Points	923 Points	833 Points
Cutler (Recommended)	784.5 Points	923 Points	853.75 Points

At the direction of the Board, staff will begin negotiations with the recommended selected firm, Cutler, in accordance with County CCNA procedures. A final negotiated contract will be presented to the Board for consideration at a future date.
