**Summary Explanation/Background:**

On September 5, 2012, the EMS Medical Control Board nominated Dr. David Bowden to be appointed as the EMS Medical Director. This recommendation was approved by the EMS Authority on September 18, 2012 to be effective October 1, 2012.

The intent was for Dr. Bowden to serve on an interim basis with the expectation that Dr. Angus Jameson would assume the role of EMS Medical Director once he relocated and became fully credentialed.

Dr. Jameson relocated to Florida in December 2012, attained his Florida Physician License and has attained his board certification in Emergency Medicine. Further, he has served as the Associate EMS Medical Director for the last year.


