I RECOMMEND THE BOARD OF COUNTY COMMISSIONERS (BOARD) AWARD THE QUOTE FOR ADVERTISING DELINQUENT TAX LISTS TO GULF COAST REVIEW, INC., D/B/A BUSINESS OBSERVER, SARASOTA, FLORIDA, ON THE BASIS OF BEING THE ONLY RESPONSIVE, RESPONSIBLE QUOTE RECEIVED MEETING SPECIFICATIONS. THE QUOTE IS ON FILE IN THE PURCHASING DEPARTMENT.

**Summary Explanation/Background:**

The purpose of this contract is to provide legal/official newspaper advertisement for the delinquent real estate tax list as required by the Tax Collector. On January 2, 2014, on behalf of the Tax Collector, the Purchasing Department let a quote for annual requirements to advertise the Delinquent Real Estate Tax and Tangible Personal Property Tax Lists for 2013 and 2014. The contract is for twenty-four (24) months effective March 16, 2014.

Florida Statutes, Chapter 197.402 requires the Board to select the newspaper. Therefore, although this recommendation would normally be initiated through delegated authority, the Board is requested to approve this recommendation for award.
