I RECOMMEND THE BOARD OF COUNTY COMMISSIONERS (BOARD) AWARD THE BID FOR GARBAGE / TRASH COLLECTION SERVICES TO WASTE MANAGEMENT INC. OF FLORIDA D/B/A WASTE MANAGEMENT OF PINELLAS COUNTY, ATLANTA, GEORGIA AS THE LOWEST RESPONSIVE, RESPONSIBLE BIDDER.

Summary Explanation/Background:

This contract is for garbage and trash collection services (regular and roll-off dumpsters) for County owned facilities in unincorporated areas and various parks throughout geographical Pinellas County. The thirty-six (36) month contract shall commence on April 28, 2015 containing provision for one (1) twenty-four (24) month term extension. The term extension provides for price adjustment (increase/decrease) in an amount not to exceed the average of the Consumer Price Index for all Urban Consumers for the twelve months (12) prior to extension, or two percent (2%), whichever is less. The extension is contingent upon all terms and conditions remaining the same subject to approval by the County Administrator.

This bid was originally released on October 8, 2014. After bids were received and reviewed, staff determined specifications required revision to achieve equitable results. Therefore, the original bid process was rejected and a re-bid was released, the result of which is presented for Board consideration.
