Vacancy on Local Planning Agency announced

Applications are now being accepted for one four-year appointment to the Pinellas County Local Planning Agency. This appointment is for an alternate member. Board positions are unpaid and voluntary positions.

The Local Planning Agency consists of appointed members selected from the community. The Agency has the responsibility to make recommendations to the Board of County Commissioners regarding the development of, or changes to, the Comprehensive Plan. The Agency also reviews amendments to the Land Development Code, including zoning changes, and a variety of other items, to ensure that they are consistent with, and serve to implement, the Comprehensive Plan.

Per Florida Statutes Chapter 163.3174, each local government is required to establish a Local Planning Agency.

Meetings of the Agency are held on monthly basis, usually the second Thursday at 9 a.m. in the Board Assembly Room at the County Courthouse in downtown Clearwater.
