Public Hearing to receive comments on a four-year rate schedule for proposed retail and wholesale rates for the Pinellas County water, sewer and reclaimed water systems.

Recommended Action:

I RECOMMEND THE BOARD OF COUNTY COMMISSIONERS (BOARD) RECEIVE PUBLIC COMMENT AT THE FIRST OF TWO PUBLIC HEARINGS ON THE PROPOSED FOUR-YEAR RATE SCHEDULE FOR RETAIL AND WHOLESALE RATES FOR THE WATER, SEWER AND RECLAIMED WATER SYSTEMS.

Summary Explanation/Background:

The Home Rule Charter of Pinellas County and the Florida Statutes provide for the Board, by resolution, to prescribe and collect reasonable rate charges for services provided by the County's Utility systems, and set such rate charges which will produce sufficient revenues to cover all expenses of operation, maintenance, renewal of facilities, to pay for when due, all bonds and interest, including reserves, and for other funds required for facilities issued under a resolution.

On February 24, 2015, the Board granted authority to advertise for and schedule a public hearing on May 5 for the proposed revised retail and wholesale rates for the water, sewer and reclaimed water system.

A rate consultant, Burton and Associates, has reviewed data to determine the revenue requirements of the water, sewer and reclaimed water system. The summary results were presented to the Board at their meeting on January 13, 2015.

The public hearings will consider a four-year rate schedule for the water, sewer and reclaimed water system. The rate for retail and wholesale water customers is proposed to increase 1.75% per year for both volumetric and base rates. Increases are required to provide for improvements and upgrades to the water system infrastructure and to maintain adequate cash flows, reserves, and cost of purchasing water from Tampa Bay Water.

The rate for retail and wholesale sewer customers is proposed to increase 1.00% per year starting in fiscal year 2017 for both volumetric and base rates. Increases are needed to maintain adequate debt service coverage, cash flows, reserves, and improvements and upgrades to the South Cross and William E. Dunn Water Reclamation Facilities.

The proposed increase in reclaimed water retail rates is \$1.00 per year, and a user fee increase of \$0.05 per year per 1,000 gallon volume. Rates for reclaimed water wholesale customers are established by agreement with the governmental entities purchasing reclaimed water from Pinellas County Utilities and are proposed to increase by 5% per year. All wholesale reclaimed water agreements allow for rate adjustments as approved by the Board and each customer has been notified in writing of the proposed increases for October 1. The Reclaimed Water System is currently operating at a deficit. The increases are required due to ongoing costs for renewal and replacement of the systems and increased operating and maintenance costs such as electricity and chemicals.

This four-year approach provides an indication of proactive financial management of utility systems desired by bond rating agencies, but does not preclude the Board from making adjustments annually.

The proposed increases will be effective for billings on or after October 1, 2015 and on October 1 for each subsequent year, unless adjusted by the Board.

The purpose of the hearing before the Board is to receive public comments on the proposed rates. As authorized by the Board, a second public hearing will be held May 19, 2015 for final adoption of the resolutions.

RESOLUTION NO. 15-_____

RESOLUTION ADOPTING REVISED RETAIL AND WHOLESALE RATES FOR PINELLAS COUNTY WATER, SEWER AND RECLAIMED WATER SYSTEMS

WHEREAS, the Pinellas County Water System provides water service to customers within its water service area, as designated by the Board of County Commissioners of Pinellas County, Florida, at retail water rates; and

WHEREAS, the Board of County Commissioners of Pinellas County, Florida, had heretofore entered into contracts with wholesale customers to furnish water at a wholesale rate; and

WHEREAS, Sections 373.1962 and 163.01, Florida Statutes, created Tampa Bay Water as an independent governmental entity for the purpose of developing, recovering, storing and supplying quality drinking water to its member governments; and

WHEREAS, Pinellas County is a member government of and receives its water supply from Tampa Bay Water; and

WHEREAS, the costs associated with the design, acquisition, construction, and operation of water supply facilities required to supply water to its customers is now the responsibility of Tampa Bay Water and is included in the unitary rate charged to its member governments; and

WHEREAS, pursuant to home rule and statutory authority, the Board of County Commissioners of Pinellas County, Florida, has considered the increased costs associated with improvements and upgrades to the infrastructure, maintaining adequate cash flows, reserves and debt service coverage and purchasing water from Tampa Bay Water; and

WHEREAS, the Pinellas County Sewer System provides sewer service to customers within its sewer service area, as designated by the Board of County Commissioners of Pinellas County, Florida, at retail sewer rates; and

WHEREAS, the Board of County Commissioners of Pinellas County, Florida, had heretofore entered into contracts with wholesale customers to treat sewer at a wholesale rate; and

WHEREAS, pursuant to home rule and statutory authority, the Board of County Commissioners of Pinellas County, Florida, has considered the increased costs associated with maintaining adequate debt service coverage, cash flows, reserves and improvements and upgrades to the South Cross Bayou Water Reclamation and William E. Dunn Water Reclamation Facilities; and

WHEREAS, Resolution 11-164 previously established the Definitions and Rate Structure for Pinellas County Sewer System; and

WHEREAS, Pinellas County recognizes that highly treated reclaimed water from its wastewater treatment facilities is a beneficial resource; and

WHEREAS, the Pinellas County Board of County Commissioners recognizes that one of the most viable and effective potable water conservation alternatives available is reuse of reclaimed water; and

WHEREAS, Pinellas County desires to make reclaimed water available for reuse in the community in an effort to further conserve its potable water resources, when economically feasible; and

WHEREAS, the Board of County Commissioners of Pinellas County, Florida, had heretofore entered into contracts with wholesale customers to provide reclaimed water at a wholesale rate; and

WHEREAS, pursuant to home rule and statutory authority, the Board of County Commissioners of Pinellas County, Florida, has considered the costs associated with ongoing costs for renewal and replacement of the systems and increased operating and maintenance costs; and

WHEREAS, the Home Rule Charter of Pinellas County and the Florida Statutes authorize the Board of County Commissioners of Pinellas County, Florida, to revise water, sewer and reclaimed water rates when necessary by resolution; and

WHEREAS, the Florida Statutes and Pinellas County Ordinances require a notice and a Public Hearing on the proposed revised water, sewer and retail reclaimed water rates; and

WHEREAS, proper notice was provided through the billing process as required in section 180.136, Florida Statutes; and

WHEREAS, a Public Hearing was held on the 5th day of May, 2015 on the proposed revised water, sewer and reclaimed rates; and

WHEREAS, a Public Hearing was held on the 19th day of May, 2015, with due and proper notice given on this Resolution adopting these revised water, sewer and reclaimed water rates;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Pinellas County, Florida, in regular meeting duly assembled this 19th of May, 2015, that said revised Water, Sewer and Reclaimed Water Rates are adopted, as the said rates being as follows:

- II. UNFUNDED SYSTEMS – Availability Charge Program – The Availability Charge is to pay for the cost of construction of the reclaimed distribution mains. The Availability Charge will be billed to all properties in the Readiness to Serve Zone, whether connected to the system or not. Improved properties will be billed on a single utility account, however, if an improved property has separate utility accounts for each dwelling unit, then the Availability Charge shall be divided equally among each account. Customers with irrigation wells as of the effective date of Ordinance 97-103 approved December 9, 1997 are exempt from the Availability Charge unless such property connects to the reclaimed water system. Customers may pre-pay the Availability Charge. Customers who connect to the system will pay the Availability Charge and User Fee.

Properties upon which a residential dwelling or other structure cannot be built due to special parcel designation or size limitation shall be exempt from the Availability Charge and reclaimed service will not be made available.

NOTICE IS HEREBY GIVEN that preliminary public hearings will be held before the Pinellas County Board of County Commissioners beginning at 9:30 a.m. on May 5, 2015 at the Pinellas County Courthouse, Fifth Floor, Clearwater, Florida, at which time the Board of County Commissioners will consider proposed new Retail Water, Wholesale Water, Retail Sewer, Wholesale Sewer and Retail Reclaimed Water rates.

NOTICE IS HEREBY GIVEN that public hearings will be held before the Pinellas County Board of County Commissioners beginning at 6:00 p.m. on May 19, 2015 at the Pinellas County Courthouse, Fifth Floor, Clearwater, Florida, at which time the Board of County Commissioners will consider proposed new Retail Water, Wholesale Water, Retail Sewer, Wholesale Sewer and Retail Reclaimed Water rates.

This notice is being issued under the authority granted by law to the Board of County Commissioners of Pinellas County, Florida, as a rate-making body for the establishment of rates to be charged by Pinellas County.
