Annual Certification of the Lealman Solid Waste Collection and Disposal District Non-Ad Valorem Assessment Roll

Recommended Action:

I RECOMMEND THAT THE BOARD OF COUNTY COMMISSIONERS, SITTING AS THE GOVERNING BODY OF THE LEALMAN SOLID WASTE COLLECTION AND DISPOSAL DISTRICT, ADOPT THE NON-AD VALOREM ASSESSMENT ROLL AND AUTHORIZE THE CHAIRMAN TO CERTIFY THE NON-AD VALOREM ASSESSMENT ROLL TO THE TAX COLLECTOR PRIOR TO SEPTEMBER 15, 2015.

Summary Explanation/Background:

The Lealman Solid Waste Collection and Disposal District was created in order to provide uniform residential solid waste collection and disposal services within the District. The adoption of the assessment roll is an annual requirement that will allow funds to be collected by the uniform method of collection (on the "Notice of Ad Valorem Taxes and Non-Ad Valorem Assessments") to pay for the costs of collection and disposal services and administration of the District. The assessment roll is for the period January 1 through December 31, 2015.

The Non-Ad Valorem Assessment Agreement with the Pinellas County Property Appraiser for the continued annual development and maintenance of the assessment roll was approved August 23, 2011 and has automatic year-to-year renewals.

The assessment is based on a residential unit basis. Each parcel within the District this year will be assessed an amount equal to \$14 per residential unit on the parcel per month (\$168 annually per residential unit).

Pursuant to Florida Statute 197.3632(5), a public hearing is not required for multi-year assessments.

Fiscal Impact/Cost/Revenue Summary:

This assessment will provide all revenue necessary to pay for collection and disposal services within the District, as well as all administrative costs associated therein, without impact on the General Fund.
