Subject: Proposed Subthreshold Amendment to the Countywide Plan Map

Recommendation:

THE PINELLAS PLANNING COUNCIL RECOMMENDS THE BOARD OF COUNTY COMMISSIONERS (BOARD), IN YOUR CAPACITY AS THE COUNTYWIDE PLANNING AUTHORITY, CONDUCT A PUBLIC HEARING AND APPROVE CASE CW 15-14 AS SUBMITTED BY THE CITY OF OLDSMAR.

Summary Explanation/Background:

The Countywide Planning Authority has received one case concerning a subthreshold amendment to the Countywide Plan Map that was reviewed by the Pinellas Planning Council on September 9, 2015.

Case CW 15-14 – City of Oldsmar:

4.4 acres more or less, located at 200 Forest Lakes Boulevard; proposed to change from Retail & Services to Employment.

This amendment by Pinellas County qualifies as a Tier II Type A Subthreshold amendment, because it is fewer than 10 acres in size and meets the Employment category conversion criteria. The subject site contains construction office and warehouse buildings. The property is for sale and the applicant proposes to continue using this property with a similar use.

The PPC, by a vote of 11-0, recommended approval of Case CW 15-14.

ORDINANCE NO. 15-_____

AN ORDINANCE AMENDING THE COUNTYWIDE PLAN MAP OF PINELLAS COUNTY, FLORIDA, BY ACTION ON CASE NUMBER CW 15-14 INITIATED BY THE CITY OF OLDSMAR AND TRANSMITTED TO THE BOARD IN ACCORDANCE WITH THE SPECIAL ACT; PROVIDING FOR AMENDMENT TO THE PLAN; PROVIDING FOR SEVERABILITY; PROVIDING FOR FILING OF THE ORDINANCE; PROVIDING FOR OTHER MODIFICATIONS THAT MAY ARISE FROM REVIEW OF THE ORDINANCE AT THE PUBLIC HEARINGS AND WITH RESPONSIBLE AUTHORITIES; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, a proposed amendment to the Countywide Plan Map, which is an element of the Countywide Plan of Pinellas County, Florida, has been presented at a public hearing to the Board of County Commissioners in their capacity as the Countywide Planning Authority; and

WHEREAS, notices of public hearings have been accomplished as required by Chapter 2012-245, Laws of Florida; and

WHEREAS, procedures of the Special Act and County Charter have been followed concerning the Pinellas Planning Council and the Countywide Planning Authority for proposed amendment to the Countywide Plan; and

WHEREAS, the City of Oldsmar initiated a proposed amendment which was considered at a public hearing by the Pinellas Planning Council on September 9, 2015, with recommendations made by the Council that are documented in the Council reports referred to as Exhibit A; and

WHEREAS, the Board has conducted a public hearing and taken action that is documented by ordinance for approvals or partial approvals and partial denials and by resolution for denials, with both documents including the relevant Council reports as attached.

NOW, THEREFORE, BE IT ORDAINED by the Board of County Commissioners of Pinellas County, Florida, acting as the Countywide Planning Authority in regular meeting duly assembled on October 6, 2015, as follows:

Section 1. Amending the Countywide Plan Map


The Countywide Plan Map for Pinellas County adopted in Section 2 of Ordinance 15-30 is amended to reflect the changes adopted as follows:

#CW 15-14 4.4 acres m.o.l., located at 200 Forest Lakes Boulevard, from Retail & Services to Employment

Section 2. Severability. If any Section, Subsection, sentence, clause, phrase, or provision of this Ordinance is for any reason held invalid or unconstitutional by a Court of Competent Jurisdiction, such holding shall not be construed to render the remaining provisions of this Ordinance invalid or unconstitutional.

Section 3. Filing of Ordinance; Effective Date. A certified copy of this ordinance shall be filed with the Secretary of State with the Ordinance and Exhibit A to be filed with the Clerk of the Circuit Court. This Ordinance shall take effect upon filing with the Department of State.

I. AMENDMENT INFORMATION

From: Retail & Services (R&S)

To: Employment (E)

Area: 4.4 acres m.o.l.

Location: 200 Forest Lakes Boulevard, Oldsmar, FL (City of Oldsmar Jurisdiction)

II. RECOMMENDATION

Council recommend to the Countywide Planning Authority that the proposed map amendment to Employment be approved.

III. BACKGROUND

This proposed amendment is submitted by the City of Oldsmar and seeks to reclassify a parcel totaling 4.4 acres from Retail & Services to Employment. This amendment qualifies as a Tier II Type A Subthreshold amendment, because it is less than 10 acres in size and meets the Employment category conversion criteria (Section 6.5.4.5, Countywide Rules).

The subject site contains construction office and warehouse buildings. The property is for sale and the applicant proposes to continue using this property with a similar use (construction office and storage of construction equipment and materials).

IV. FINDINGS

Staff submits the following findings in support of the recommendation for approval:

The proposed amendment qualifies as a Tier II subthreshold amendment (Type A); and

The proposed amendment to Employment recognizes both the current and proposed use for the site and is consistent with the criteria for utilization of this category.

PPC Action: The Council recommended approval of the amendment from Retail & Services to Employment (vote 11-0).

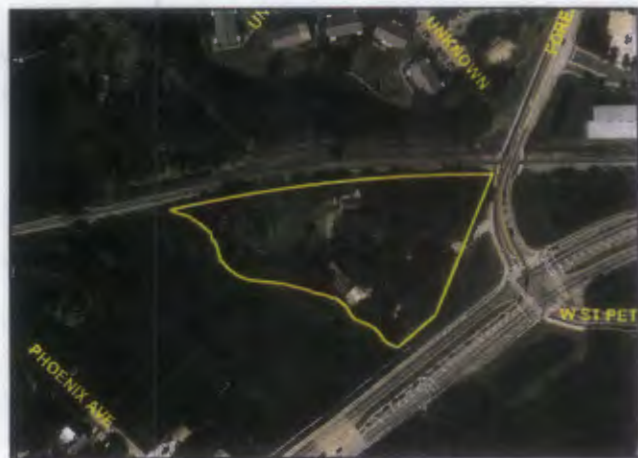
CPA Action:

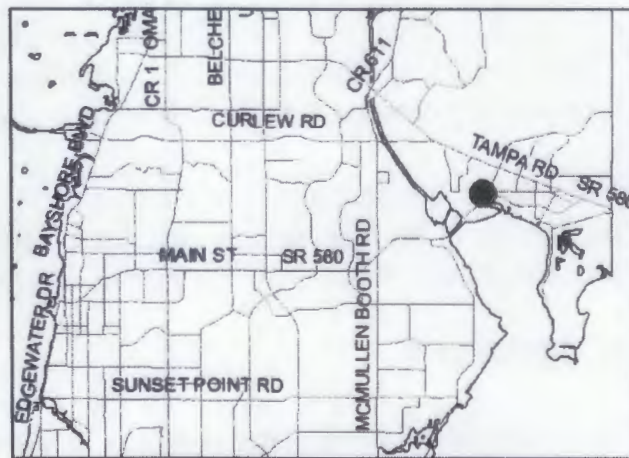


Current Future Land Use
