**Summary Explanation Regarding Serving on the CareerSource Pinellas Board**

Pinellas Opportunity Council, Inc. (POC) is the Community Action Agency in Pinellas County. POC is the designated anti-poverty agency whose mission is to help alleviate the conditions of poverty, revitalize local communities and promote self-sufficiency. Our State of Florida Department of Economic Opportunity Act contract requires us to have an MOU with CareerSource Pinellas, requiring both parties to assure the coordination and partnership of the CSBG Program and the Workforce Florida, Inc. One Stop delivery system, services and information. One facet of our service delivery model assists clients with employment and training needs. In enhancing our partnership with CareerSource Pinellas, POC does the following: serves as a referral source to the One Stop Centers for employment assistance; coordinates/partners with the Junior Achievement Program annually in its efforts to operate STEMTEC; has staff that serves on the One-Stop Consortium Committee; provides financial assistance as needed to clients enrolled in WIA; and has staff that serves as volunteers to read at schools.

Having a seat on the CareerSource Pinellas board of directors enhances our partnership and facilitates our collaborative efforts. With the term of our current representative to the board expiring, I welcome the opportunity to serve on the CareerSource Pinellas board.
