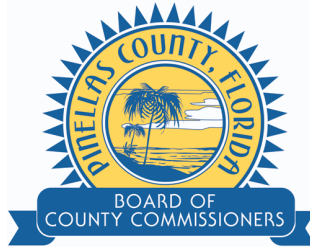

3. Metropolitan Planning Organization/Pinellas Planning Council Presentation - Whit Blanton, Executive Director

Noting the importance of completing the transportation network and improving accessibility in the County to facilitate economic opportunities, Mr. Blanton related that in the next year the MPO and PPC will focus their resources on achieving economic goals, supporting redevelopment in target areas, encouraging higher density and mixed-use development in appropriate locations, and improving safety. He discussed initiatives for enhancing beach access, improving connectivity in the Gateway and mid-county area, developing work plans for spotlight emphasis areas such as the U.S. Highway 19 corridor, and the upcoming Complete Streets grant program for transformative road projects.

Mr. Blanton pointed out that the MPO is working to strengthen its partnership with the Pinellas Suncoast Transit Authority (PSTA); and that the organizations will hold a workshop on January 22 to discuss aligning transportation priorities, enhancing safety and access around transfer points, and additional opportunities for transfer locations.

Mr. Blanton related that a CSX Transportation representative attended a recent Tampa Bay Transportation Management Area Leadership Group (TMA) meeting and offered the opportunity to acquire CSX rail lines for use as a regional passenger transportation corridor; and that the group, comprised of representatives of the Pasco, Hillsborough, and Pinellas MPOs, may ask the state to acquire the lines, pending the results of a Florida Department of Transportation premium transportation study to be initiated later

this year; whereupon, he noted that it will be important to explore potential opportunities to maximize the CSX corridor in terms of the region's economic, housing, and multimodal transportation goals.

Commissioner Long invited Mr. Blanton to attend a meeting of the Tampa Bay Regional Planning Council and repeat his presentation, noting that the Council has hired a new Executive Director; that the group plans to make transportation its number one priority for the coming year; and that it would be significant for the agencies to be "on the same page" regarding the issue.

Commissioner Seel indicated that she is pleased with the progress of the TMA; and that the three counties are working together in a productive way, noting that the group has established regional priorities; and that it may revisit the possibility of regionalizing the MPOs; whereupon, she related that the CSX corridor was a topic of discussion in 2005, and finally there is an opportunity to move forward.

Stressing the importance of connecting with local residents, Commissioner Eggers thanked Mr. Blanton for his perspective of reaching out to address the concerns of the community, for working closely with PSTA, and for his leadership.

**4. Tampa Bay ferry pilot program presentation - St. Petersburg Mayor Rick Kriseman**

Referring to a PowerPoint presentation titled *High Speed Ferry St. Petersburg to Tampa*, a copy of which has been filed and made a part of the record, St. Petersburg Mayor Rick Kriseman introduced the pilot program proposal, noting that a ferry service would enhance transportation options available to county residents; and that a joint project may have a statewide and even a countrywide impact.

He discussed the proposal, noting that the City of St. Petersburg would be the party of record for the pilot program which would run from October 15, 2016 through April 15, 2017; that the date by which a vessel deposit needs to be provided was changed in the timeline from June 1, 2016 to April 1, 2016; and that the vessel would operate roundtrips Tuesdays through Sundays from downtown St. Petersburg to downtown Tampa; whereupon, he explained the advantages of the chosen locations.

In discussing the projected costs, Mayor Kriseman indicated that a single vessel operation would total approximately \$1.3 million, and a second vessel would add approximately \$900,000; that the participating governments would be involved as partners and are asked to contribute \$350,000 each; and that the City of St. Petersburg, as the lead government entity, would be involved in negotiations with the operator company, HMS Ferries; whereupon, he asked that the County make a firm financial commitment of \$350,000 by earmarking the funds, contingent upon a negotiated agreement and a business plan acceptable to all participating parties. In addition, he requested that the County provide assistance in lobbying for funding of a second vessel, as well as in marketing and soliciting sponsorships and co-sponsorships.

During discussion, Mayor Kriseman addressed concerns and responded to questions by the members pertaining to the need for a backup vessel, future funding requests, uncertainty of a return on the County's financial investment, the potential for state and federal funding, features of the ferry and selection of the service provider, ticket pricing and parking fees, duration of the ride, and involvement of the Pinellas Suncoast Transit Authority.

Mayor Kriseman indicated that the City of St. Petersburg has already committed its portion of the requested funds, Hillsborough County is in support of the program and is currently seeking funds, and the City of Tampa is considering the proposal; that the price of a ticket is yet undetermined, but is a critical factor; that it is anticipated that customers would include tourists, as well as local residents using the ferry service to commute to work and for leisure; and that potential HMS Ferries profit numbers would be disclosed in the upcoming business plan.

Commissioner Seel noted that the County commitment would set a precedent for other cities to request funds for similar purposes, and Commissioners Morroni and Eggers agreed; whereupon, Commissioner Eggers expressed concerns about government funds being requested for a risky venture, the County being in the middle of a fiscal year, and insufficient information and timeframe to contemplate the proposal. Mayor Kriseman explained the reasons for the compressed timeframe, noting that plausible opportunities could be missed, and pointed out that it is a pilot program; that while there may not be a return on the investment, the County exposure is limited to \$350,000; and that utilizing the waterways could potentially have a positive impact on the quality of life and economic development in the region, and Commissioners Long and Welch expressed their enthusiasm and an interest in further exploring the endeavor.

Discussion ensued regarding possible funding sources, including Tourist Development Tax revenue and the BP oil spill settlement; whereupon, Chairman Justice clarified that today the Board would indicate its level of interest by voting on the concept and proceeding to seek funds. Mr. Woodard requested flexibility related to options for recommending a funding source and indicated that he would present recommendations at the next BCC meeting, but adoption of a legal agreement to commit funds will require research and will take place at a future meeting.

**A motion was made by Vice-Chairman Long, seconded by Commissioner Welch, that the concept for the pilot program, contingent upon a business plan, be approved; and that Mr. Woodard be directed to identify potential funding sources. The motion carried by the following vote:**

## 5. Human Trafficking Proclamation

Presented to Christa Hernandez, representing the "Loving You Where You Are At" organization; Donna Lancaster, representing Community Campaign Against Human Trafficking; Pinellas County Sheriff Bob Gualtieri; and Major David Dalton, Clearwater Police Department. On behalf of the BCC, Chairman Justice asked the County residents to become a community that is more aware of the issue and supportive of the victims, with an intolerance for human trafficking; whereupon, Sheriff Gualtieri and Major Dalton thanked the Board for its leadership with regard to the Human Trafficking Ordinance and further stressed the importance of public and governmental support.

Commissioner Seel commended the Clearwater Police Department on many years of leadership in bringing the region together on the issue and thanked Major Dalton; whereupon, Commissioner Eggers requested information regarding additional County efforts to assist the victims of human trafficking.

Authority granted for the Clerk record the resolution. Letters of no objection received from all appropriate parties. Interested property owners were notified as to the date of the public hearing. Staff recommended the vacation be granted. No correspondence has been received. No citizens appeared to be heard.

Responding to query by Commissioner Eggers, Mr. Woodard explained that no sign was posted on the property because the vacation is of an easement, not a right-of-way; whereupon, he pointed out an amendment made to the draft resolution with regard to relocation of a drainage pipe by the petitioner.

Related that she had attended the Civil Citation Program Task Force meeting and found it very informative.

Chairman Justice

Discussed the possibility of holding eTownHall meetings or workshops at locations throughout the county to encourage public input; and following discussion, noted that he is working with the County Administrator to develop a list of appropriate facilities.

Noted that today is the opening day of the 2016 Legislative Session, thanked the legislators for their service, and wished them safe travels.
