- Point R:** Neighborhood Convenience Store (2 new adjacent homes built on former county owned lots)
- Point S:** Neighborhood Hot Spot (The Association worked with the Community Policing Unit who in turn worked with the landlord to move the problem off site. The problem, however, only moved a few feet away to a vacant/boarded structure that is owned by an out-of-state property owner).
