| Discussion | <p>With Bryan stepping down as GIS Manager and moving into the GIS Solutions Architect role, BTS is currently looking for a new GIS Manager. It is the desire of BTS to split out some of the current roles of the GIS Manager between the Architect and GIS Manager. Tom Fredrick mentioned that there were 40 candidates for the GIS Manager job. That has been narrowed down to 10 and telephone interviews are in the process in order to get it down to 3 to where the eGIS team will be able to interview and some of the eGIS Steering Committee members as well. The hope is to have a new manager in place by the first of the year. Pam reminded Tom that if 2 members of the committee are in one room it is considered a public meeting and advised to have individual meetings if necessary.</p> <p>Pam also stated that as she understands Bryan skillset is more on the technical end of GIS, she wanted him to know that he was the right fit for the GIS Manager job and to not underestimate his ability as manager. | Discussion | Bryan updated the committee that the raw point file data has been promised to be delivered next Friday (12/9/2016). This will allow use of the data for those projects and applications that have been waiting. The derivative products are scheduled to be delivered by the end of the year. Once eGIS has received the raw files, the working group will be notified. |

| SWFWMD Ortho Aerial Initiative and Co-Funding – FY 17 | |

| Discussion | eGIS has partnered with SWFWMD for ortho aerals for 2017. They have ranked their vendors and are currently in negotiations with Surdex to fly the aerals sometime the first week of January 2017. Bryan is working with Al Karlin from SWFWMD on this. Pam mentioned that SWFWMD covers 15 or so counties in Florida and whereas in the statutes it states that the Property Appraiser is responsible for the aerals, most have partnered up with SWFWMD in this respect. It was also mentioned that they are doing the same in FY 18 and that will be looked into also. |

| Pictometry – Notice to Proceed for Oblique Imagery Acquisition | |

| Discussion | In light of the SWFWMD partnership for the ortho aerals, eGIS has worked with Pictometry to fly oblique imagery in 2017, even though BTS only has these flights budgeted every two years. BTS will keep this going as long as the budget permits. A purchase order has been made for these for 2017 and eGIS is working with Pictometry to try to coincide the flight within the same timeframe as the orthos. |

| AECOM – Historical Aerial Georeferencing Project | |

| Discussion | eGIS worked with Public Works to contract AECOM to help modernize (georeference) historic imagery datasets that are in the county. With this first phase of the project, from 1997 to the 1980's and some of the 1970's are involved. These will eventually be added to the AIRS application, which has aerals from 1997 to present. Pam mentioned that aerals play a major part in property assessment as well as public records request for disputes. John Bennett asked if there was an interface in which the aerals can overlay from year to year. Bryan mentioned that right now in the AIRS application there is a swipe tool. Pam also mentioned that Orange County has a tool that uses a slide bar that will show the year progression. eGIS will look into this. |

| Discussion | <p>Some of the accomplishments from the year were mentioned such as migration of all legacy data (including Utilities), new focused applications, upgraded 911 geocoders, damage assessment training and support, and collector applications for various departments.</p> <p>Bryan also mentioned that as of noon (11/29/2016) the MapGuide applications have been redirected to the new ESRI viewers. The retirement of the legacy applications was scheduled for the end of the year but because of an update of Java on 11/28/2016 by BTS, this latest version is not compatible with the remaining legacy MapGuide applications, therefore both WebGI and PCUGIS (legacy versions) are no longer functional. Those that are having issues or have questions concerning the new applications are to call the BTS Operations Center at 453-HELP.</p> <p>Jill DeGood mentioned that the Sheriff's ACISS program still hasn't been converted to the new geocoders. Bryan stated that the Sheriff's server is not affected.</p> |

| Review of eGIS Pipeline/Backlog | |

| Discussion | <p>A copy of the BTS Pipeline for eGIS projects was handed out during the meeting for those to review. The projects are prioritized by number starting with 1000 and any priority number with 9999 are projects that have been completed. Bryan stated that from now until the end of the year the eGIS team is going to work to complete some of the projects on the pipeline that are currently in progress. After the new year the pipeline will be adjusted and reprioritized with the help of the working group.</p> <p>One thing that was mentioned is that there are a few projects on the list that are part of the Enterprise Asset Management project, such as help with the data collection of Solid Waste and Parks, which are currently being worked on with the departments.</p> <p>Kelly Hammer Levy mentioned that they worked with HARPS recently that did a data collection effort of assets on the trails that could include data for Parks. She mentioned that Steve Harper in Parks didn't know about the HARPS effort until a few weeks ago so this may help his effort.</p> <p>Randi Kim asked about the Utilities Data Base Clean-up and why that had a completion date of 4QTRFY18. Bryan mentioned that when the migration of the Utility data was done there were many things that are now being identified and will need some clean up. eGIS has been working with Jeremy Capes and Jay Perkins on how this clean-up effort is to go forward.</p> <p>Randi Kim also asked if the Waste Water/Stormwater Countywide Task Force should become a project on the list, whereas to try and gain the infrastructure to other cities into the eGIS database. It was discussed as if this is an eGIS effort or a consultant effort. Kelly Hammer Levy mentioned that this task was part of the Vulnerability Assessment project and is written into the scope, that a consultant could be used instead of the county resources. Randi asked about the difficulty in doing this and Bryan answered that not all municipalities are working with the same data model so it makes it difficult and time consuming. Pam mentioned to be mindful to call in the need of political power to be able to work together, cities may need to be reminded of the bigger picture.</p> |

| Item #1 | Decision needed to be made on when to hold the quarterly meetings for 2017. It was decided by the group that the first meeting of the year should be held sometime in February for budgeting purposes. Blake Lyon asked if the new priority pipeline list could be sent out to the departments in January to work into their budgets if needed. |
| Item #2 | <p>Marty Rose wanted to thank Pam for her service on the eGIS Steering Committee and the BTS Board. He also wanted to present to the committee an opportunity from ESRI. The county has been asked to be part of a promotional video to show how the county has and is working with the ESRI platform. Marty has brought this to the BTS Board Chair and the County Attorney and they have no issues with this as long as it isn't endorsing any products but promoting the Pinellas County area. Pam said that it is great to be singled out by ESRI and a great opportunity but that she was not wanting to be in the video. John Bennett asked about the timeline and if we, the county, would have final editing rights to the video. Pam asked Marty if he was seeking approval from the eGIS Steering Committee to move forward and he said yes. It was motioned by John Bennett for approval, but with the certain caveats to protect the county, which should be vetted through the County Attorney (Jason Ester). Jake Stowers seconded, all in favor. Motion was approved to move forward with ESRI on a promotional video, with caveats.</p> |

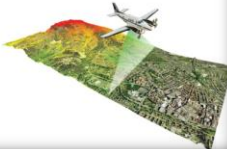

Delivery of raw LIDAR Point Cloud files – Last week in November
Delivery of derivative products – December 31st, 2016




Project Updates – SWFWMD Aerials/CFI



eGIS has opted to partner with SWFWMD in FY17 and co-fund their ortho imagery acquisition.


Southwest Florida Water Management District has qualified and ranked their Aerial Vendors for the FY17 flights:

- 1.) Woolpert
- 2.) Surdex
- 3.) Quantam Spatial




Negotiations with top-ranked vendors are ongoing. eGIS will work with SWFWMD on flight and delivery schedule once final contract negotiated with qualified vendor.


Pictometry FY17 Services



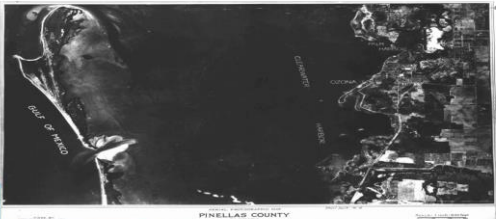
- BTS has contract in place with Pictometry through 2020 to provide aerial data acquisition services (with annual options)
