



Fertilizer Applicator License Requirement Information for Landscape Fertilizer Applicators in Pinellas County

Any person or company providing fertilizer application services within Pinellas County must display a Pinellas County vehicle decal. Complete the steps below to avoid violation of the Pinellas County Fertilizer Ordinance. For information visit: www.pinellascounty.org/fertilizer

- **STEP 1:** Complete a state-approved training course such as the *Green Industries Best Management Practices (GIBMP)* from a University of Florida County Extension office (every County offers the GIBMP course). The course can be taken at the Pinellas County Extension classroom by registering online at www.pcehort.eventbrite.com. The course is also available as an online self-paced course through the GIBMP Program website: <https://gibmp.ifas.ufl.edu>. Note: there are no Pesticide CEUs for the online course. If you need assistance with registration, please call Pinellas County Extension at (727) 582-2100.
- **STEP 2:** Complete the application for the FDACS LTD Commercial Fertilizer Applicator license either by printing and mailing this form <http://forms.freshfromflorida.com/13677.pdf> and submit with required documents & photo to FDACS. Processing time is 4-6 weeks. **Or by creating an account online and paying online to receive your fertilizer license within 24hours at** <https://aesecomm.freshfromflorida.com/>. Each applicator must have this license **regardless** of any other FDACS licenses held.
- **STEP 3:** Receive your vehicle decal by faxing a completed affidavit, page 2 below, to Pinellas County Natural Resources at fax# 727-464-4403.
