## Pinellas and Pasco County Attended Death Report Form

The investigating officer should report the following information to the Office of the Medical Examiner by fax on all apparent natural deaths that occur outside of a hospital (inpatient) or nursing home when the attending physician licensed in Florida has committed to sign the death certificate.

However, if the death appears to be suspicious, homicide, suicide, accident, or if the investigating officer has any question or concerns and needs to speak to the on duty Medical Examiner Investigator, he or she should call 727-582-6800.
