New Benefit Plan Year Begins January 1, 2017

Medical and dental premiums for 2017 will be deducted from the December pension check to pay for January 2017 coverage. Private Pay member payments are due by **Friday, December 23**.

Important benefit plan design changes to keep in mind

For all medical plan enrollees:

- **Davis Vision** is your vision care provider as of January 1, 2017. Look for your welcome kit including your ID card, benefits summary and local provider directory to be delivered to your home in early January.

For enrollees in the Point of Service United Healthcare (UHC) medical plan:

- Primary care physician and urgent care copays increase from \$5 to \$25.
- Specialist copays increase from \$5 to \$35.
- Emergency Room copay increases from \$150 to \$250.

You will receive new UHC ID cards in early January.

For Medicare Advantage enrollees:

- The out-of-pocket maximum is increasing by \$250 to \$1,750.

For enrollees in the **consumer driven health plan**, Pinellas County's contribution to your Health Savings Account will be posted on January 3rd.

- Q.** *In the event of my passing, who does my family contact?*
- A.** Your loved ones should contact Employee Benefits via email at employee.benefits@pinellascounty.org or by phone at (727) 464-4570, and contact the Florida Retirement System (FRS) at (866) 446-9377.
- Q.** *What happens to my coverages for 2017 if I did nothing during annual enrollment?*
- A.** Your 2016 coverages will continue for 2017; however, be mindful of the plan design changes noted at left.
- Q.** *I become Medicare eligible when I turn 65. What am I supposed to do to get coverage?*
- A.** Documentation from our office regarding your transition and enrollment in the Medicare Advantage Plan will arrive at the address we have on file for you. We advise you to enroll in Medicare Part A and Part B, which can be done three months prior to the month in which you turn 65.
