Nominees for Mobile Medical Unit Advisory Council:

Co-Applicant Board Composition Requirements

- Board must be composed of individuals, a majority of whom are being served by the center and, this majority as a group, must represent the individuals being served by the center in terms of demographic factors such as race, ethnicity, and sex.
- Board must have at least 9 but no more than 25 members, as appropriate for the complexity of the organization,
- No more than two (2) MMU Advisory Council members may be Pinellas County Board of County Commission members,
- The remaining non-consumer members of the board shall be representative of the community in which the center's service are is located and shall be selected for their expertise in community affairs, local government, finance and banking, legal affairs, trade unions, and other commercial and industrial concerns, or social service agencies within the community;
- No more than one half (50% - for CHCs) of the non-consumer board members may derive more than 10% of their annual income from the health care industry.
- No employee or immediate family member of an employee of the public agency, or the co-applicant may serve as a member of the co-applicant board.

Present at Meeting: Sgt. Zachary Haisch, Jerry Wennlund (late arrival due to EOC meeting), Valerie Leonard*, Sean Murphy*, Rhonda Abbott and Laurie Lampert. Staff and community members present: Drew Wagner (phone), Daisy Rodriguez, Rhonda O'Brien, Dale Williams, Elisa DeGregorio, Katherine Simone (PCSO), and Meghan Lomas. (*Consumer)

The regular meeting of the Mobile Medical Unit Advisory Committee (MMUAC) was called to order at 3:09 pm.

i. Chairman's Report

- i. **New Member Appointment/Removal of Members:** No new members. Laurie Lampert is filling in for Pam Long, who has left. Nicole Fischer and Preston have moved out of the area. Sgt. Haisch will work to recruit additional members from Safe Harbor.
- ii. **Approval of Previous Minutes:** A motion to approve the minutes dated September 6, 2016 was made by Laurie Lampert and seconded by Sean Murphy. The Council **unanimously approved** the minutes.
- iii. **Credentialing & Privileging:** Rhonda O'Brien identified three (3) new DOH dentists and thirteen (13) new specialists recommended to the Council by the Medical Executive Committee for credentialing and Privileging. The list of names are highlighted in yellow in the meeting packet. Rhonda Abbott made a motion to accept the dentists and specialists for credentialing and privileging and the motion was seconded by Sgt. Haisch. The Council **unanimously approved** the motion.
- iv. **Unfinished Business:** In follow-up to last month's meeting, the following items were discussed:
 - a. **Lealman and Tarpon Van Locations:** Rhonda Abbott inquired if further discussions were had regarding the feasibility/need to locate the van in the Lealman or Tarpon Springs areas. Ms. Rodriguez indicated that Mr. Wagner confirmed that Dr. Choe (DOH) followed up with Mr. Brickfield regarding his inquiry about possible van placement in Lealman. Mr. Wagner was pulled away from the meeting and unable to respond to the inquiry about Tarpon Springs. This item will need to be directed to Mr. Wagner.

Sgt. Haisch cautioned the council to consider the potential for Pasco County homeless individuals to seek the services of the MMU if the van were to be located in certain areas of Tarpon Springs.
 - b. **Goodwill Busing Clients to Bayside:** Ms. Abbott inquired if there were still issues with Goodwill transporting clients, by the bus load, to the Bayside clinic. Mr. Wagner will need to follow up with regards to this item.

I. Governance/Operations

- i. **Strategic Planning:** Ms. Rodriguez updated the Council that the revised brochure was completed and is now being distributed to community partners. Ms. Rodriguez has additional copies if any partners would like to make a request.

Ms. DeGregorio shared the October Newsletter with the Council. Rhonda Abbott congratulated staff and thanked them for continuing with the implementation of recommendations from the focus groups, with respect to communications.

The staff continue to meet to review progress towards the communications, access and quality recommendations from the focus groups.

- ii. **MMU Calendar:** The October calendar (included in the meeting packet) for the MMU and Bayside was presented to the Council. Ms. Rodriguez noted that the clinic and MMU will be closed on October 13th for in-service training. She requested that notice be posted at both locations to ensure patient notifications.

Ms. Rodriguez also wanted the council to note the change on Tuesdays. As of October 1st, the MMU will no longer be going to HEP every other Tuesday. The van will travel to St. Vincent DePaul (SVDP) every Tuesday. Sean Murphy noted there are some changes to the SVDP courtyard being discussed at the present time. Sgt. Haisch indicated any potential changes should not impact van usage at SVDP, as the van serves more than just SVDP clients.

- iii. **Patient Satisfaction Surveys:** The results from the August and September 2016 patient satisfaction survey were presented to the council by Rhonda O'Brien. August saw 46 survey respondents, and September has 42. The trend continues to show positive feedback with a majority of the responses being "Usually" and "Always." A couple responses indicated "Sometimes" or "Never," but overall positive. Discussion was had regarding survey responses. Some individuals include their name with their survey. Drew will follow up to see if the "Never" responses were submitted by someone who included name. If so, he can follow up to review the scenario that led to the negative experience/perception.

Ms. Rodriguez noted that question ten (10) is a new question that will be utilized to determine an overall performance assessment. Ms. Rodriguez will follow up with the quality improvement committee meeting to determine next steps in regards to benchmarks for the survey responses.

II. Fiscal

- i. **Notice of Awards:** Ms. DeGregorio reported that the County received two new Notice of Awards from HRSA. The first notice was for \$10,000 Quality Improvement (QI) award based upon last year's performance. This figure was not as large as the previous year, but could have been impacted through the workflow changes that have occurred. The second notice was for \$42,239 Delivery System Health Information Investment (DSHII). This funding will be utilized to connect the MMU's electronic health record (EHR) with other community providers to further assist in the coordination of care.

A motion to accept the two Notice of Awards was made by Rhonda Abbott and seconded by Sgt. Haisch. The motion **passed unanimously**.

Ms. Abbott inquired about the QI award and asked if Pinellas County was working with QI personnel at the other service providers. Ms. Rodriguez indicated that Stephanie Reed and her team are working on that.

Elisa DeGregorio discussed the Budget Period Performance Report (BPR) that was being developed and how the QI process has changed how this will work moving forward. Previous to the current year, the BPR reporting was developed at the end of the year and could not address any data issues in “real time.” The new process of the team meeting quarterly to discuss the reporting and workflow allows the team to address concerns near to when they arise and work to have any “issues” fixed prior to the BPR development and submission.

III. Clinical

- i. **Trend Report for Patient Counts/Encounters:** A copy of the September trend report was provided to the Council members indicating that a total of 1833 unduplicated patients were recorded from January 1st through September 30th for the program. The numbers are slightly above the same time period last year but have been picking up. Ms. O’Brien noted that based on our current projections and pace, we anticipate seeing 2,500 patients for the year, an increase over the 2,239 patients in 2015.

Dental: A copy of the dental trend report was provided to the Council as requested showing that since Bayside has opened on April 18th through September 30th, the clinic saw 216 unduplicated clients in 648 encounters. Overall, all HCH clients receiving dental care totaled 367 clients in 1111 encounters at all dental locations in the County.

Mr. Murphy inquired about the individuals noted in the dental report identified as “No Medical Home.” Ms. O’Brien indicated that DOH is working on updating this information. Dale Williams further explained the issue is missing data points. Mr. Williams explained this was a data transfer issue that DOH and PCHS are aware of and are continually working to resolve.

Phone: Ms. DeGregorio presented the September **call volume report** for the Bayside Clinic/HCH program. In the month of September, the health center received 2550 phone calls broken down as follows:

- 142 Pressed 1 for Office Hours/Locations
- 865..... Pressed 2 for Medical Appointments/Cancellations
- 251..... Pressed 3 for Dental Appointments/Cancellations
- 34..... Pressed 4 for Behavioral Health
- 61..... Pressed 5 for Specialty Care
- 430..... Pressed 6 for Providers
- 287..... Pressed 7 for All Other Questions
- 227..... Pressed 0 for the Operator
- 256..... Timed Out/Error

These figures include September 1st through the 15th, the period of the month in which the phone system remained unchanged. After September 15th, the phone system was updated to include: reduced rings, ringing two (2) desk simultaneously, added the option to indicate the call is from a provider, and added the option to press and be connected to the after hour’s number. If 6 is pressed to indicate a call from the provider, the caller will be transferred to a voicemail box direct to the nurses. This will assist in streamlining the process. Ms. DeGregorio explained there are

additional opportunities for changes to be made, if necessary, but PCHS would like to receive feedback regarding the client experience currently before implementing any additional changes.

An inquiry was made regarding a defined process for responding to voicemails. This is a questions that will need to be responded to by Mr. Wagner. Follow up is necessary to identify: how voicemails are returned, the types of calls, timeframe for return calls, and by whom the calls are returned by.

IV. Other Updates

i. New Business:

E-application: Daisy Rodriguez explained that PCHS is in the testing phase of an electronic application for services. She inquired about the naming of such a system and provided several suggestions. Discussion was had regarding the utilization of “portal.” Given the discussion it was determined that the term portal may not completely reflect the purpose of the new system. More general terms regarding the application aspect should be utilized to reduce confusion.

Medication Management Education: Laurie Lampert provided the council a copy of a one-page form she has developed to use with the clients she sees at Pinellas Hope’s respite care. She realized a need to assist the clients in becoming active health consumers. The form utilizes several questions the client should ask when seeing a doctor and converts some terminology utilized in a healthcare setting into generalized and relatable terms. The purpose of Laurie bring the form was to inform Bayside and MMU staff that she will be providing this to clients and to be on the lookout to assist these individuals with becoming informed patients.

Rhonda O’Brien inquired if the MMU/Bayside staff had anything currently available electronically that they could print out to provide all patients. Also, Rhonda Abbott indicated this could potentially be shared amongst homeless service providers to begin the education process amongst the shared clientele. Drew Wagner and Melissa Van Bruggen will need to follow up to provide the information to DOH staff and make them aware of the form.

Scenario: Ms. Lampert was uncertain if this advisory council was the appropriate forum, but wanted to inquire as to the process to identify and/or diagnose a homeless client with possible Alzheimer’s or Dementia that is beyond the scope of Pinellas Hope’s capabilities. Suggested contacts provided were for: MMU/Bayside for referral to a specialist, DCF’s Adult Protective Services, or the CARES Unit. Ms. Lampert will follow up with these possible avenues.

Bus Passes: Sean Murphy had an inquiry regarding the timeframe a client of MMU/Bayside could anticipate for eligibility to receive a PSTA bus pass. Dale Williams provided the process for which Mr. Murphy was referencing and through discussions it appears the individual addressed should be eligible. Mr. Williams requested that Mr. Murphy have the individual contact him directly to ensure the information within the database is correct to allow for access to a bus pass.

Hurricane Matthew: Jerry Wennlund provided the group an update on Hurricane Matthew. He recommended everyone stay alert as the cone heads towards Florida. Although the storm may not be a direct hit, it may be a wind event.

The meeting was adjourned at 4:37 pm.

ACA Health Care Marketplace - Open Enrollment Begins November 1, 2016

Pinellas County residents can sign up for an affordable health plan that meets their needs and their budgets at [HealthCare.gov](#) or by making an appointment with a [Pinellas County Navigator](#). Open Enrollment runs through January 31, 2017. Health coverage can start as soon as January 1, 2017 for consumers who sign up by December 15, 2016.

Pinellas County Navigators can:

- Explain various options, price packages and benefits available through the Affordable Care Act.*
- Assist in determining eligibility for coverage and where you fit on the sliding scale of subsidies and tax credits.*
- Explore any free or low-cost programs for which you may qualify.*

Mobile Medical Van Schedule Change – Effective October 1, 2016

1. How often did you get an appointment as soon as you needed?



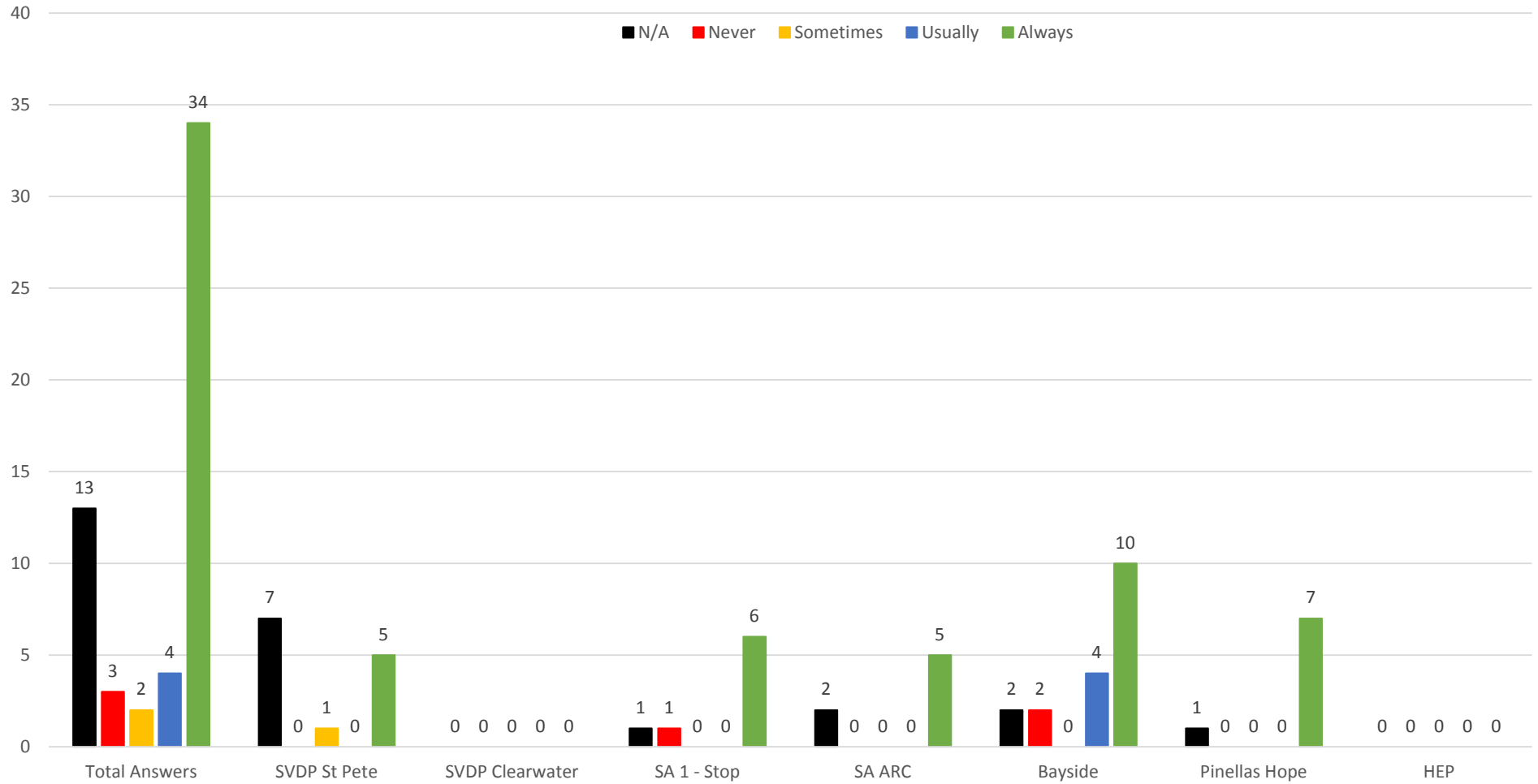

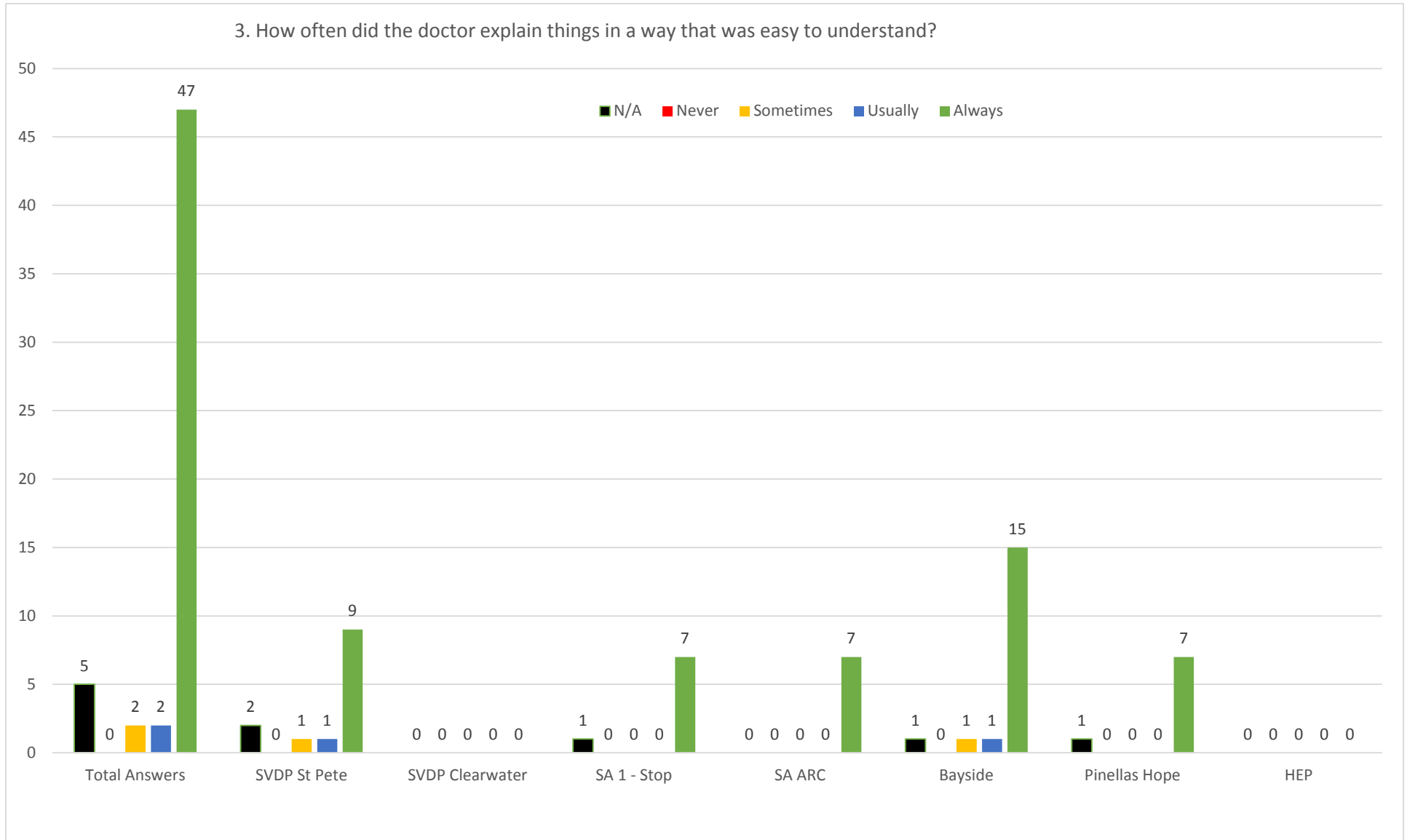
3. How often did the doctor explain things in a way that was easy to understand?

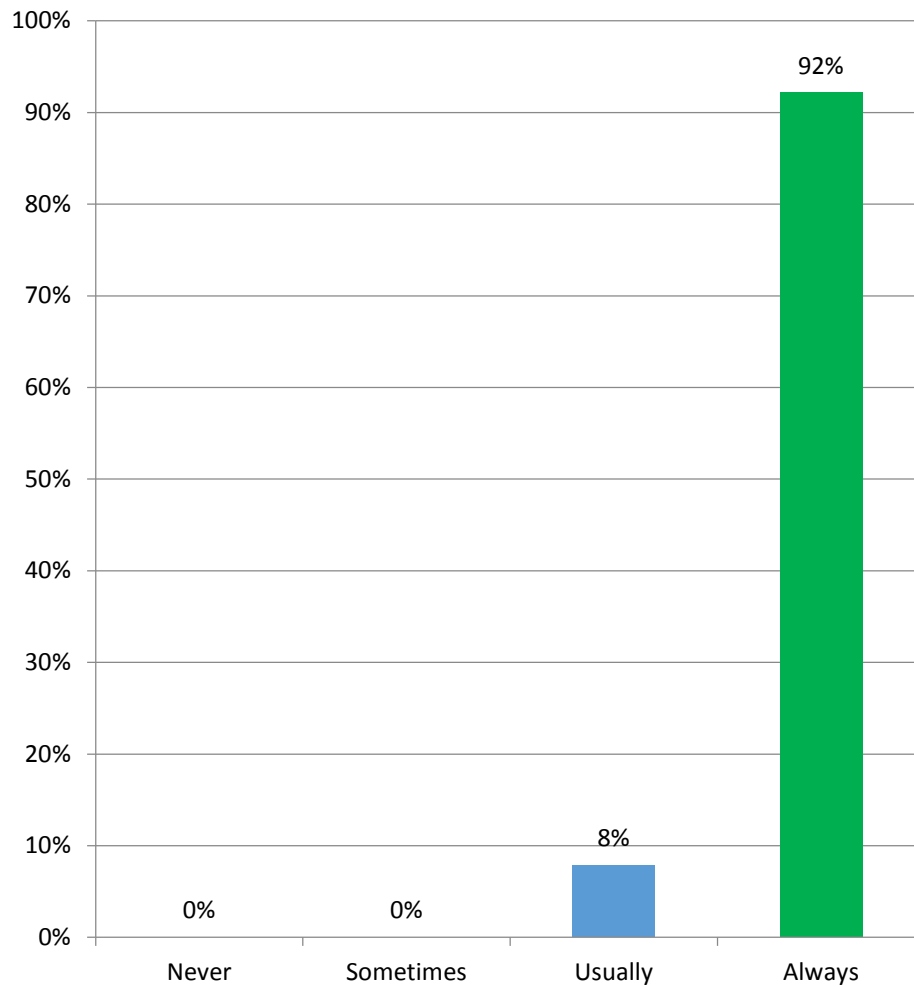

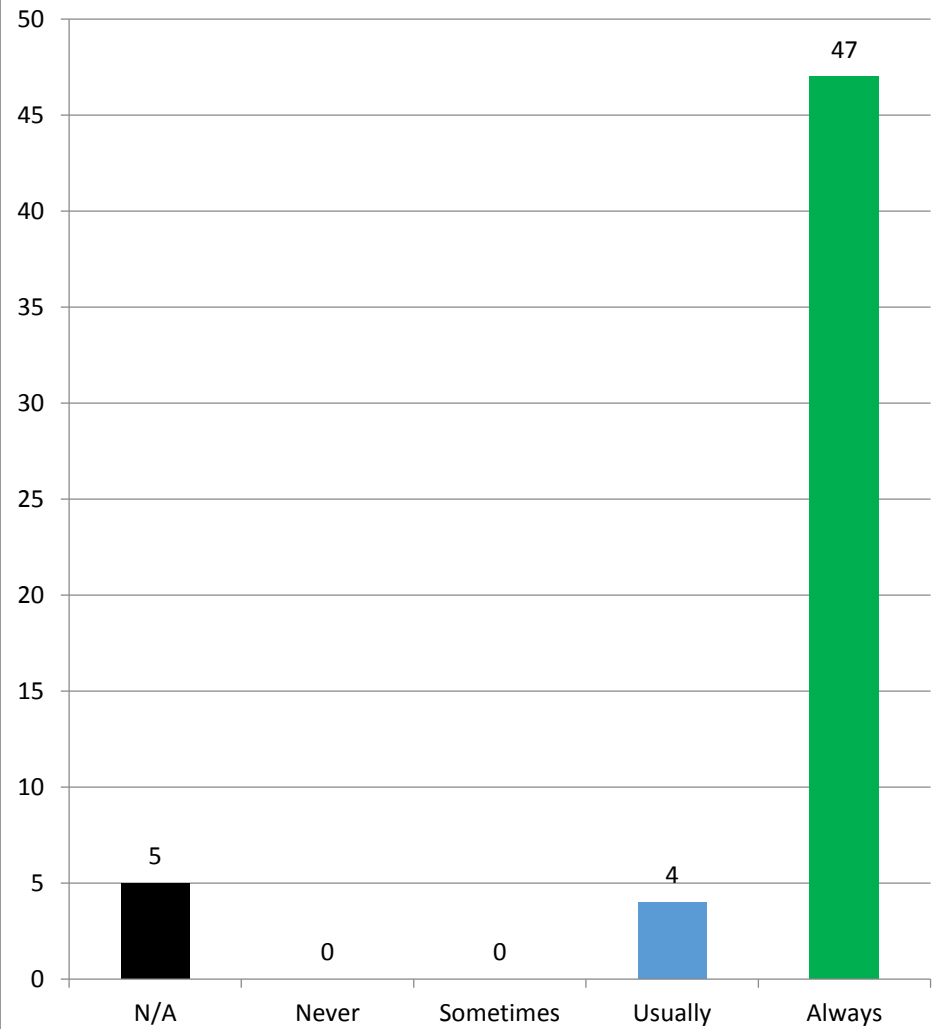

4. How often did MMU staff listen to you carefully and show respect

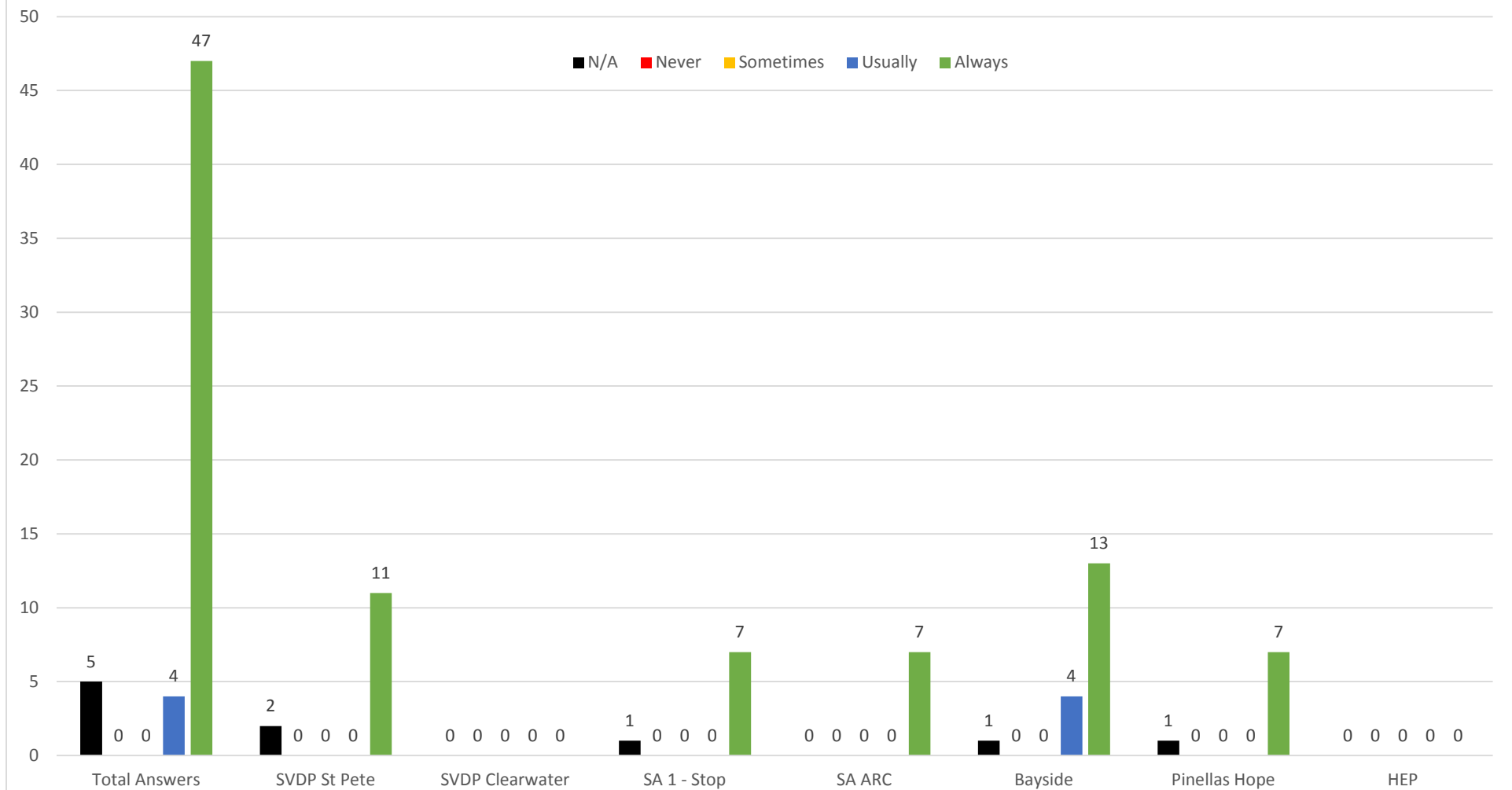

6. If you were referred to a specialist for a particular health problem, how often did the MMU staff seem informed and up-to-date about the care you got from the specialist?

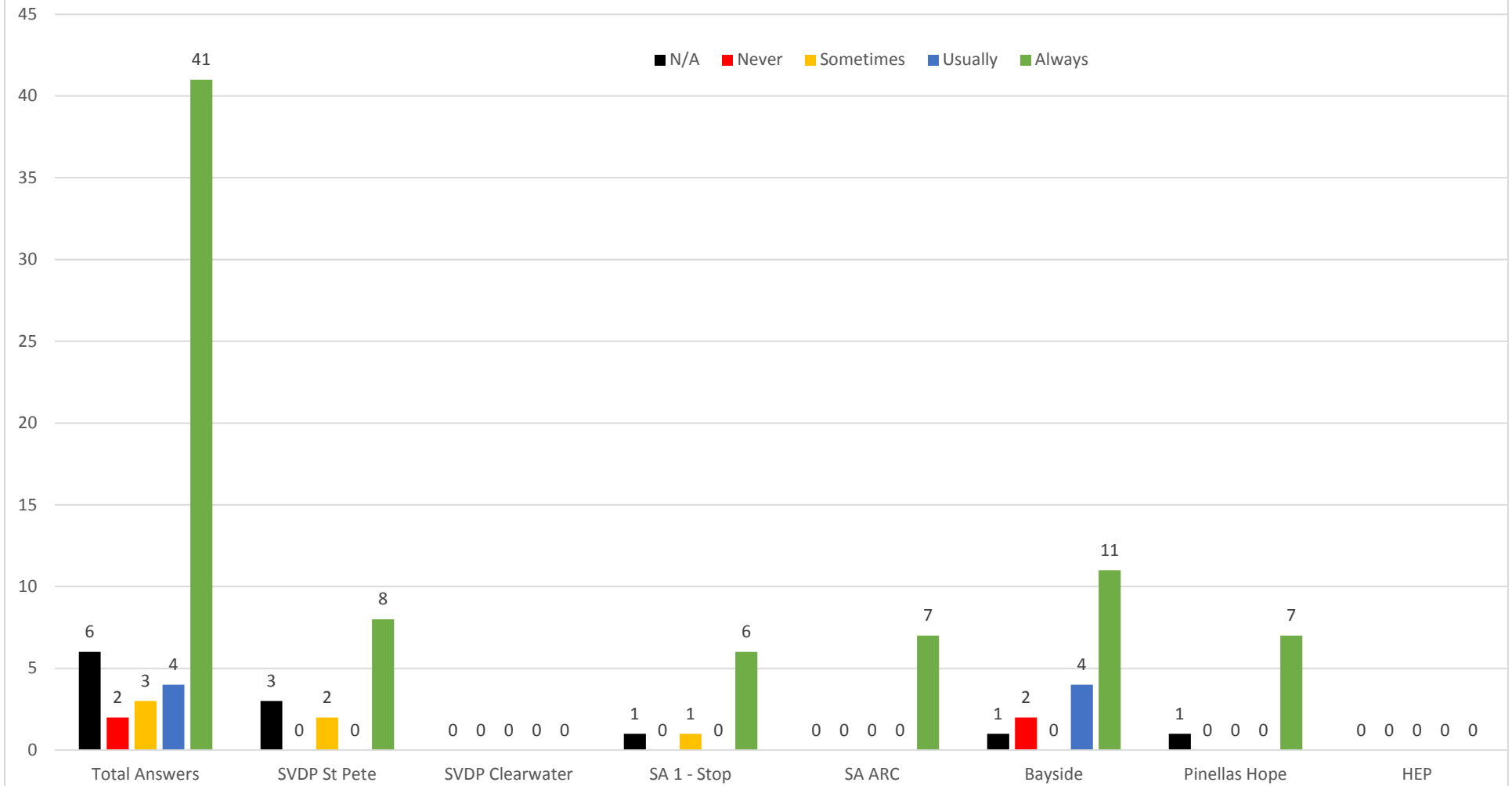

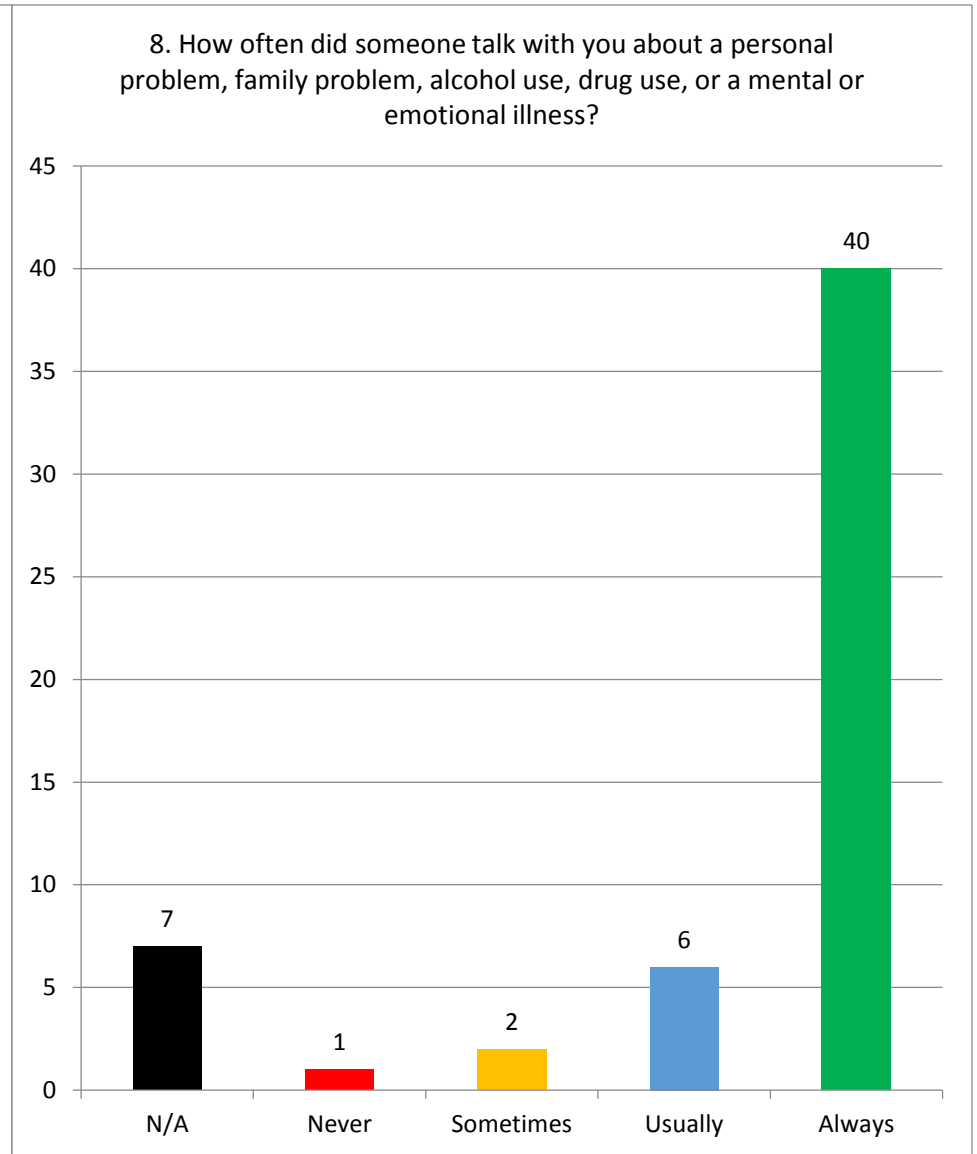
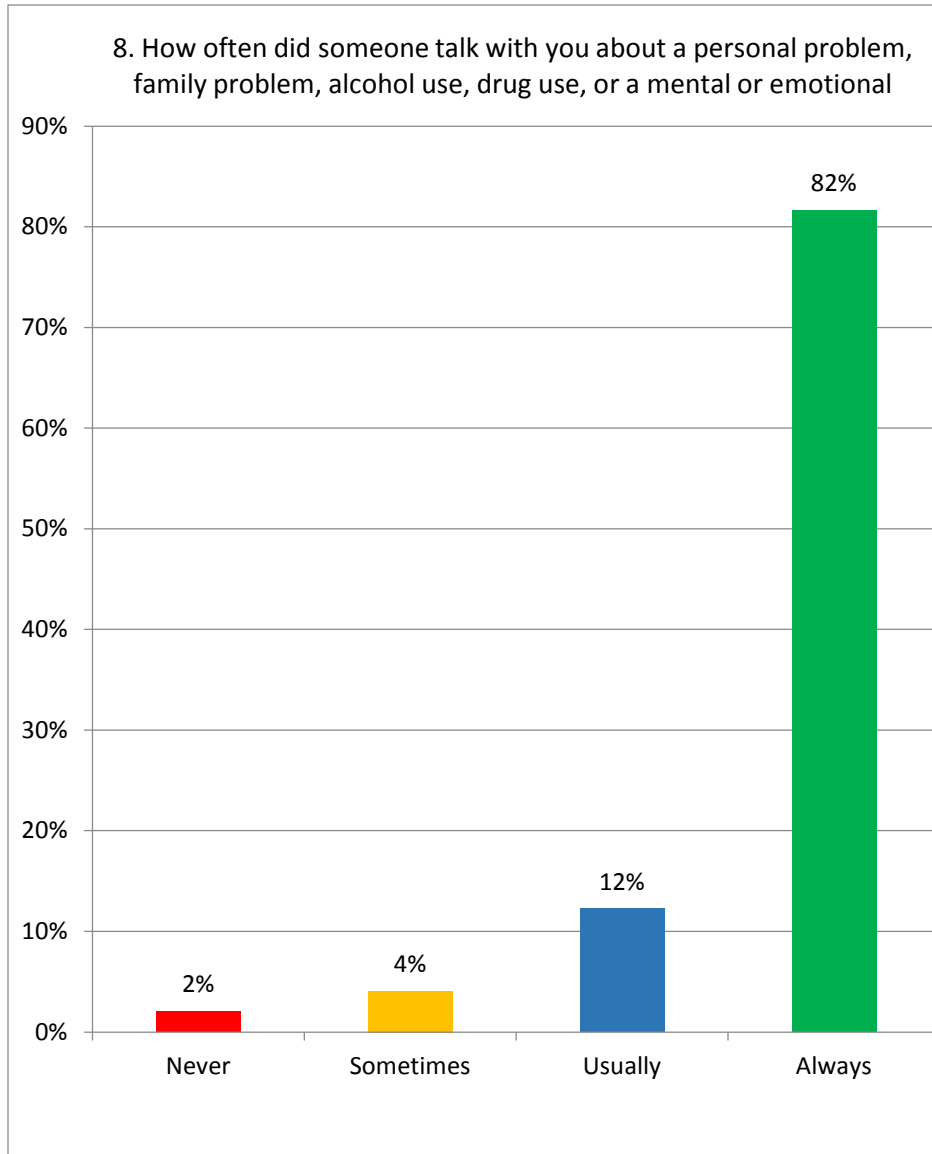

7. How often did someone talk to you about specific goals for your health?

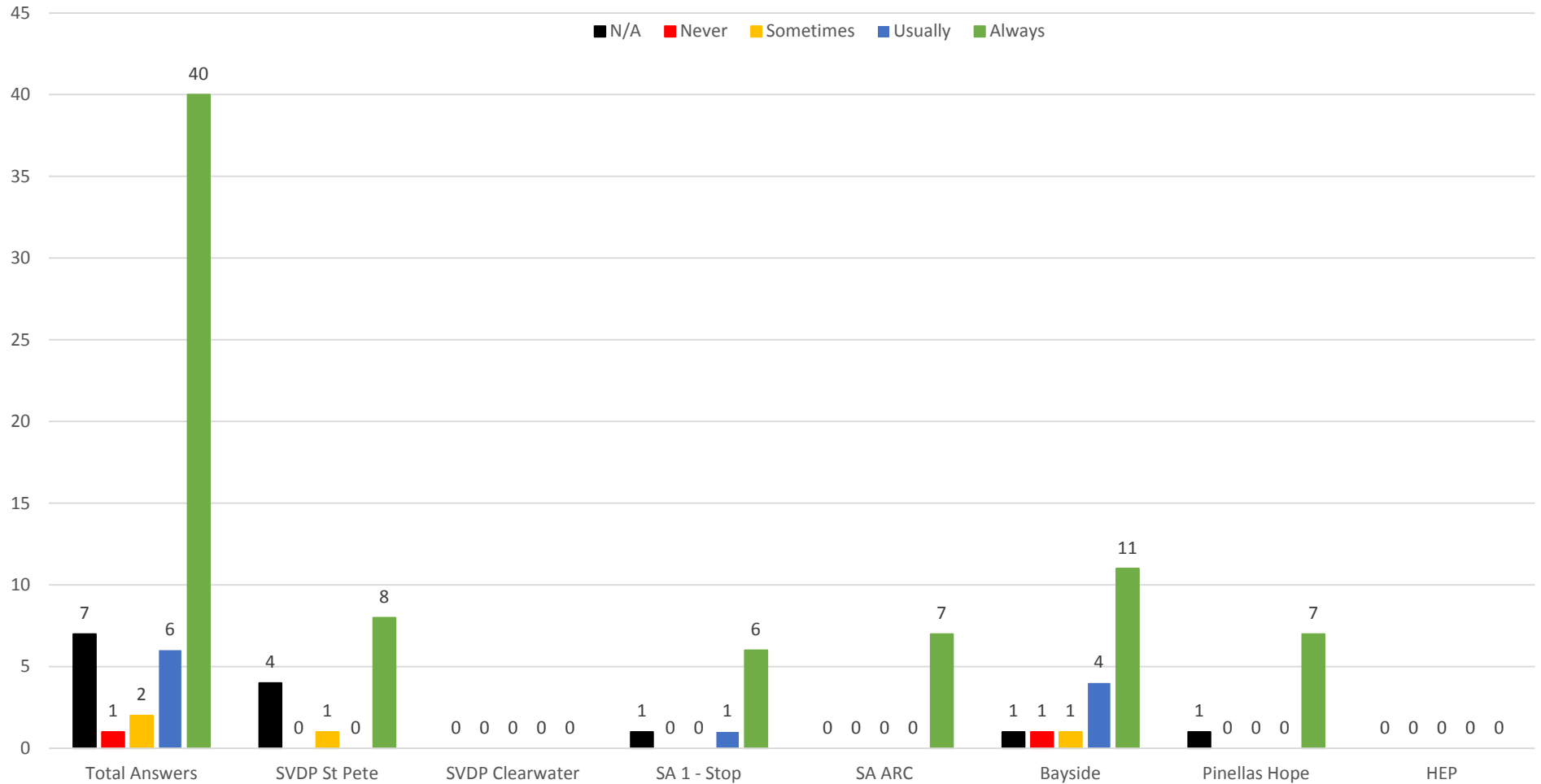

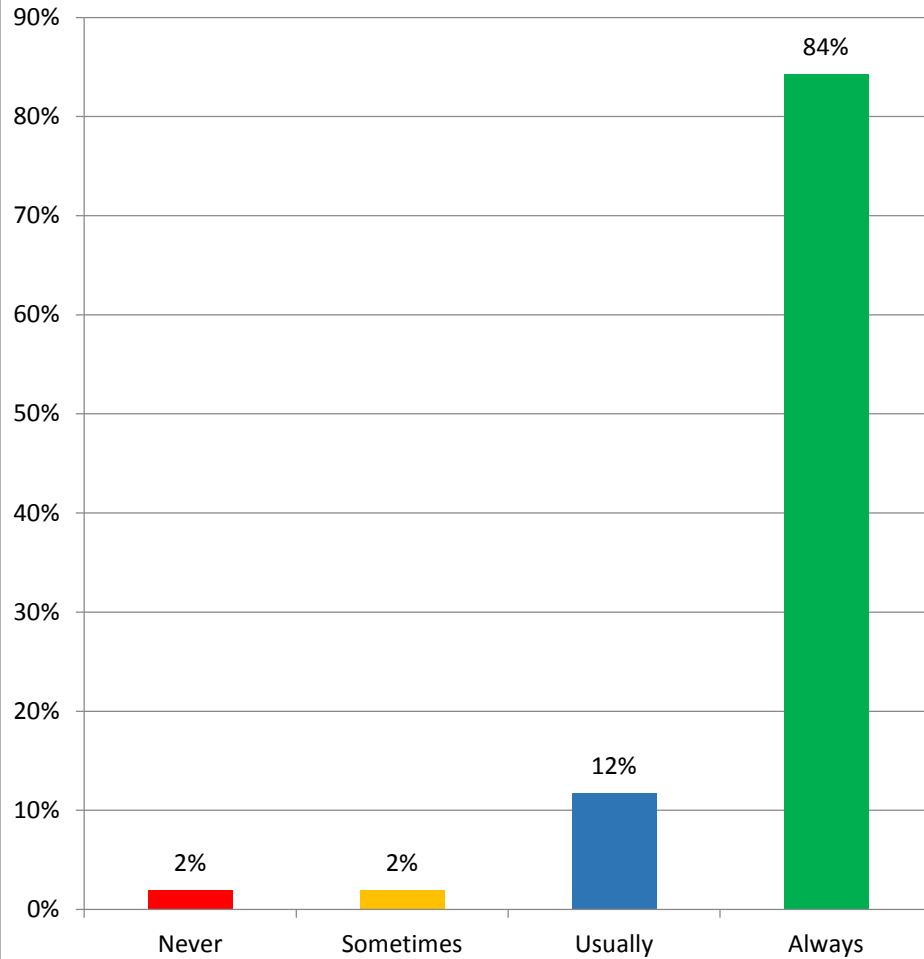

8. How often did someone talk with you about a personal problem, family problem, alcohol use, drug use, or a mental or emotional illness?

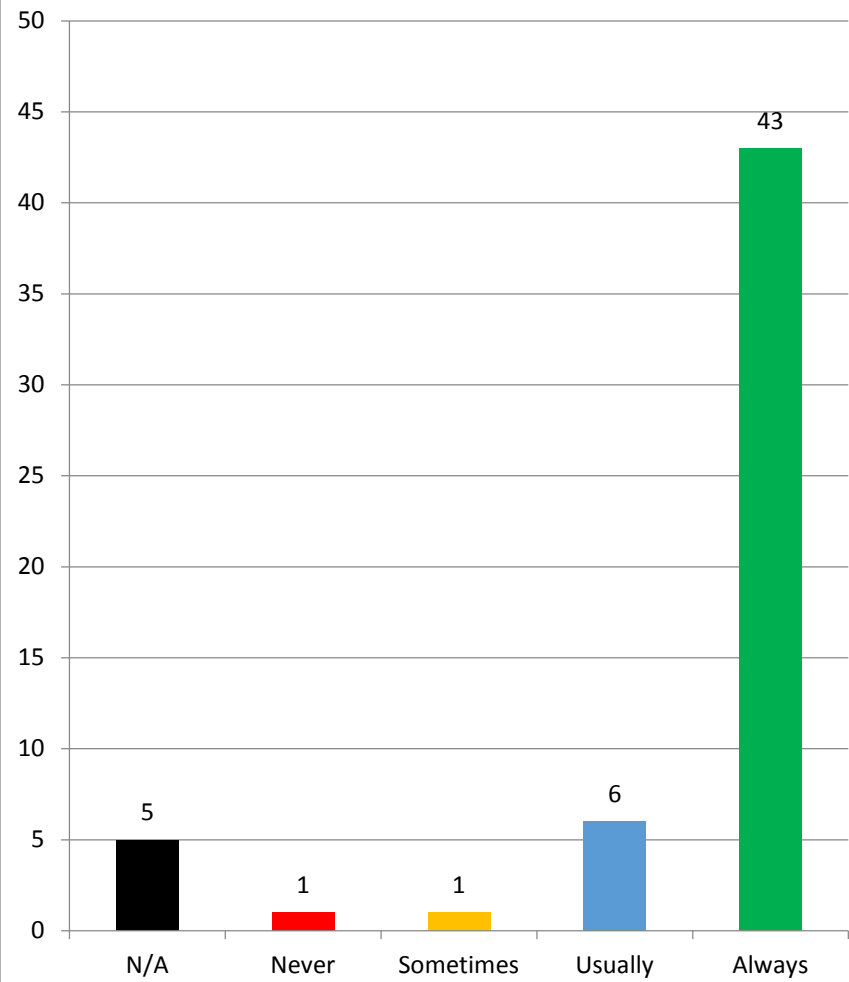

9. How frequently do you find useful the information provided to you by

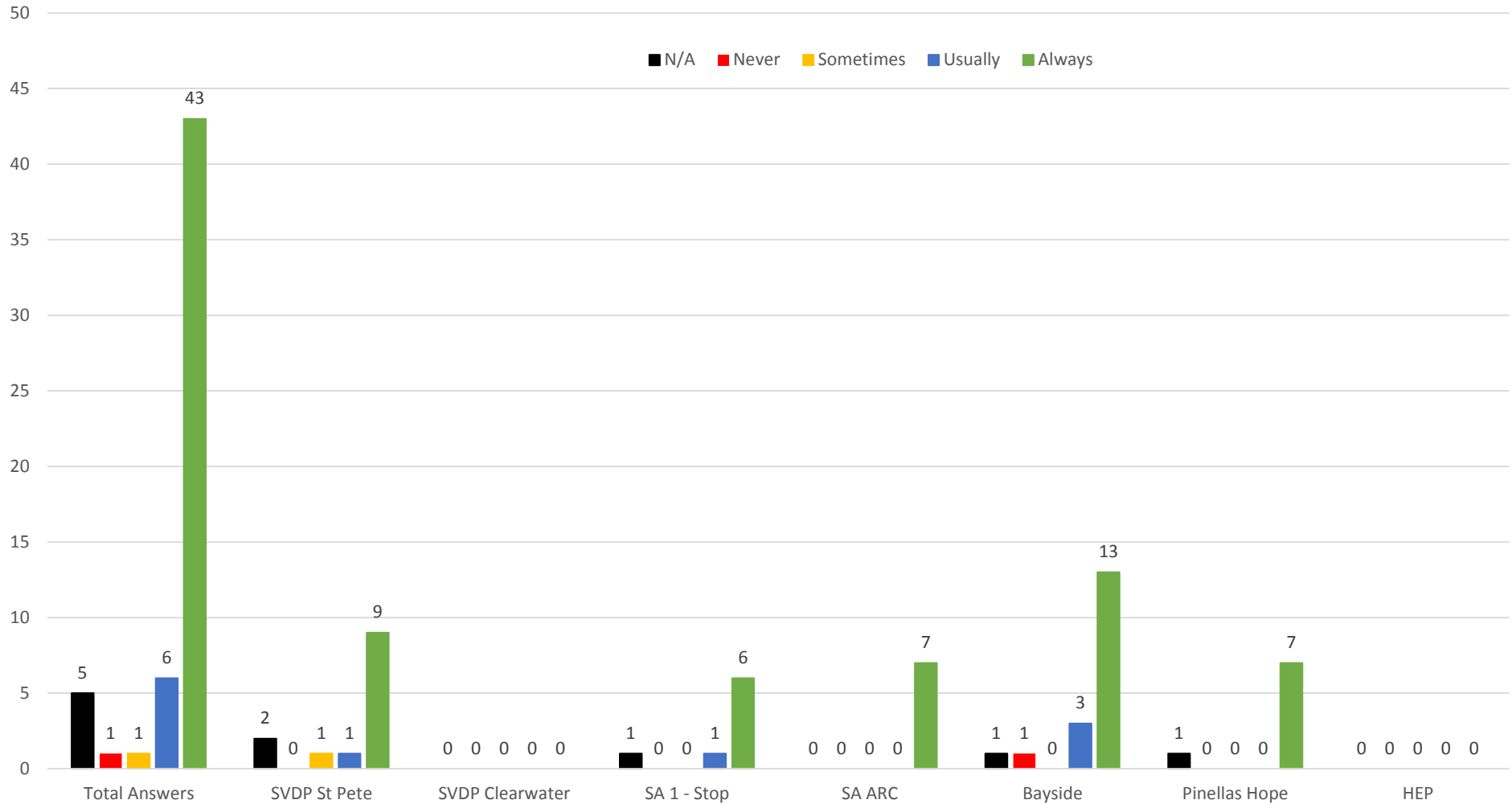

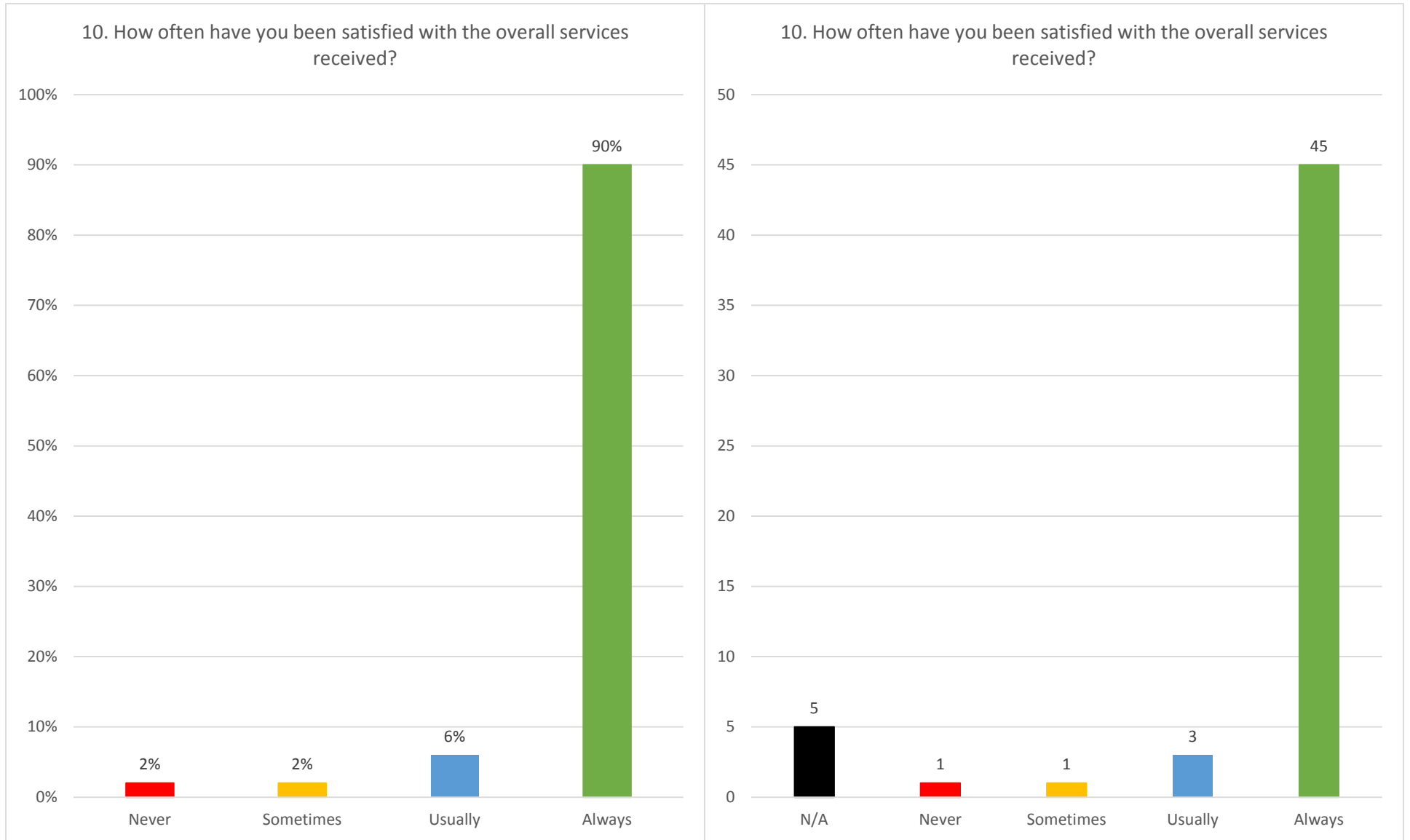

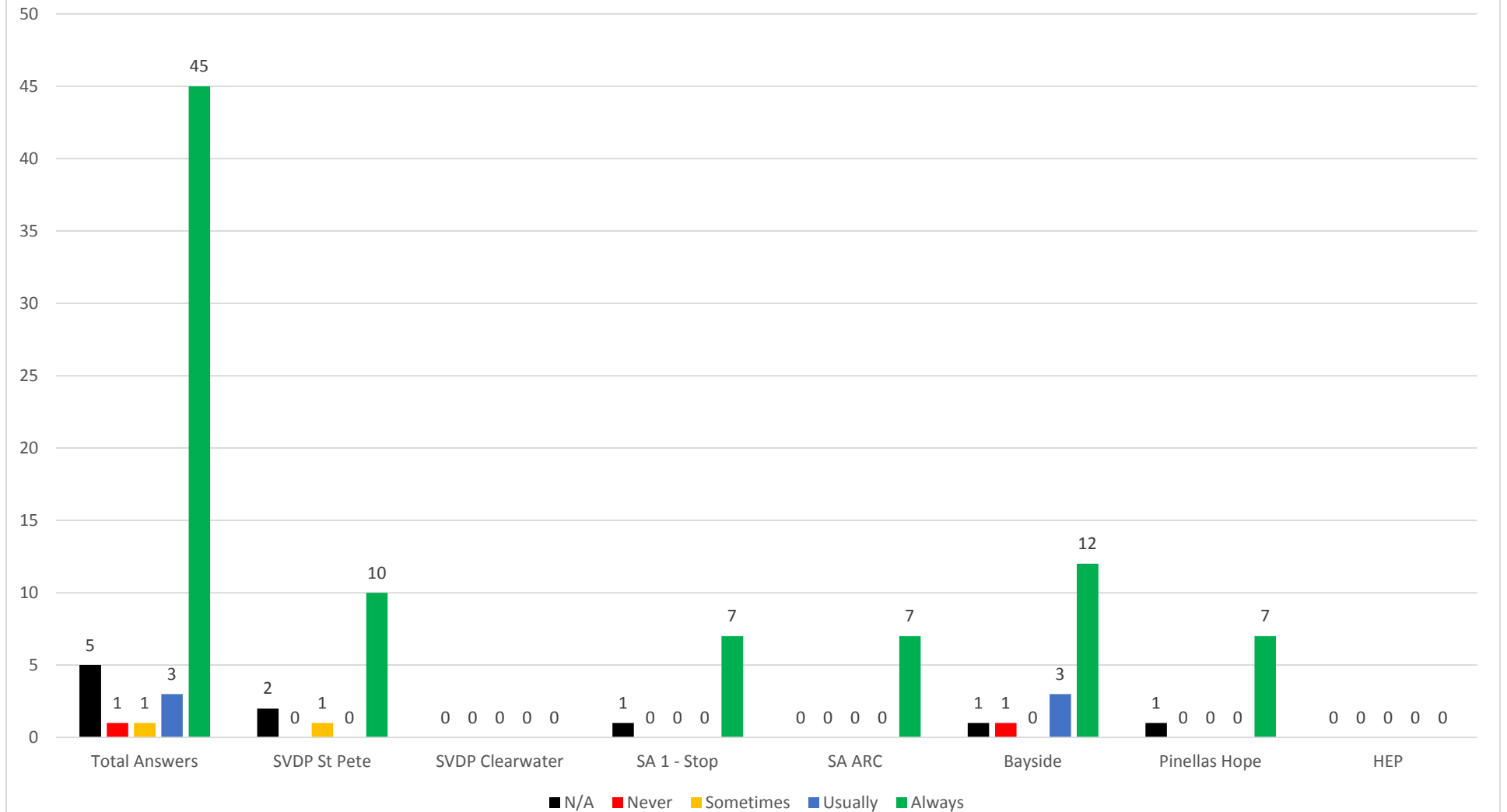
