DISCOUNT BEACH PASSES AVAILABLE:

Senior Permit: \$55.00 ANNUAL / \$30.00 - 6 MONTHS (includes 7% State Sales Tax)

Please note: You must be 65 years of age or older and provide a photocopy of your valid state driver's license or state issued identification.

Limited income passes: \$37.50 ANNUAL ONLY (includes 7% State Sales Tax)

Available by showing proof of participation in an income assistance program (i.e. EBT Card) annually or are receiving a limited income senior property exemption.

US Military Discount Pass- \$55.00 ANNUAL / \$30.00 - 6 MONTHS (includes 7% State Sales Tax)

Proof of eligibility will include one of the following:

DD-214 paperwork (military discharge papers) with an honorable or general discharge indicated. A valid Military ID card including DD Form 2, DD Form 1173, DD Form 1173-1 or DD Form 2765. The discount program does not extend to civilians holding a DoD Civilian Retiree Card. All ID's must be currently valid and the person presenting identification card must be the person requesting discount.

Disabled US Military - ANNUAL / NO CHARGE Limit of one per military applicant without possession of a state issued Disabled Parking permit/tag.

Must present an official letter from the DVA verifying a service related disability percentage AND a DD214 card or V designation on a state driver's license.

Annual permit will be mailed upon receipt of payment or credit card validation. Permit will be valid through the last day of the month one year issue date. The expiration date will be listed on the Permit. Parking is on a space available basis. Permit does not guarantee a vehicle parking space. Permit is not transferable. If you have a valid Disabled Parking Permit/Tag, you are not required to pay the daily or annual fee. Permit must be properly displayed. You do not need to be parked in a marked handicapped space as long as the permit is displayed.
