If check is returned by your bank for non-payment you will be assessed a returned check fee of \$30, in addition to the annual permit fee.

Annual Permit will be mailed upon receipt of payment or credit card validation. Permit will be valid through the last day of the month one year from the issue date. The expiration date will be listed on Permit. Parking is on a space available basis; Permit does not guarantee a vehicle parking space. Permit is NOT transferable. NOT VALID at County Boat Ramp locations.

If you have a valid Disabled Parking Permit/Tag, you are not required to pay the daily or annual fee. Permit must be properly displayed. You do not need to be parked in a marked handicapped space as long as permit is displayed.
