Recommended Action:

I RECOMMEND THE BOARD OF COUNTY COMMISSIONERS (BOARD) APPROVE THE RANKING OF FIRMS AND AUTHORIZE STAFF TO NEGOTIATE WITH THE TOP TWO (2) RANKED FIRMS, STEARNS, CONRAD AND SCHMIDT, CONSULTING ENGINEERS, INC. D/B/A SCS ENGINEERS, (SCS), TAMPA, FLORIDA, AND CDM, SMITH, INC., (CDM), TAMPA, FLORIDA, FOR PROFESSIONAL ENGINEERING CONSULTING SERVICES FOR SOLID WASTE LANDFILL AND OTHER RELATED ANCILLARY FACILITIES AND RELATED ACTIVITIES.

Summary Explanation/Background:

On June 7, 2013, in accordance with Consultant Competitive Negotiation Act (CCNA) requirements, the Purchasing Department, on behalf of the Department of Environment and Infrastructure (DEI) Solid Waste Division, let a Request for Proposal (RFP) for the intent of obtaining independent consulting and engineering services to assist staff over the next five (5) years. Services to be provided include but are not limited to: regulatory assistance; design; operational assistance; monitoring; administration; and other services as may be needed. Services will be provided for two (2) County landfills, the County's Solid Waste Management Facility aka Solid Waste Operations (SWO) which includes a scale facility; an administrative building, a mini-transfer station for individual citizen waste deliveries; a household electronics and chemical collection center; a yard waste/mulching operation; and other appurtenant facilities. The site also includes the Waste-to-Energy Facility and a Water Treatment Facility.

An evaluation committee (committee) consisting of two (2) representatives from DEI Solid Waste Division, one (1) representative from DEI Water and Sewer Division, one (1) representative from DEI Stormwater Management Division and one (1) representative from DEI- Engineering & Technical Support Division along with a representative from the Purchasing Department acting as a facilitator, met on August 21, 2013, to evaluate and score the proposals received.

Proposals were received from the following firms and ranked as follows:

1. Stearns, Conrad and Schmidt, Consulting Engineers, Inc. d/b/a SCS Engineers
2. CDM Smith, Inc.
3. Geosyntec Consultants
4. HDR Engineering, Inc.
5. S2L, Incorporated

At the direction of the Board, staff will begin negotiations with the two (2) highest ranked firms in accordance with County CCNA procedures. A final negotiated contract will be presented to the Board for consideration at a future date. The specialized knowledge base of landfill and solid waste operations experience combined with the depth of expertise these two (2) firms have in planning and executing similar type projects will be invaluable to the County.

Fiscal Impact/Cost/Revenue Summary:

Prior to negotiation, the total estimated aggregate value of this contract is in an amount not to exceed \$4,000,000.00 for the five (5) year term of this contract. The County Administrator has delegated authority to increase the upset limits of agreements as long as the negotiated rates remain the same. Funding will be derived from the Solid Waste Enterprise Fund.
