**Response:** Only the prime firm is required to submit an insurance certificate with the submittal (see Section C – Insurance Requirements for additional information). Licenses and certifications must be included with the submittal for the prime and sub-consultant(s) in order to be considered.
3. Question: Are 11x17 pages acceptable? Will they count as one page?  
**Response:** 8 ½ x 11 is the preferred page size. It will count as 1 page.
4. Question: Do the divider tabs between sections count toward the 100 page limit?  
**Response:** No.

8. Will the indemnity described in RFP Section A – General Conditions: No. 12, replace the indemnity in the Sample Agreement provided with the RFP?


