2. Question: Will the 50 points allocated to Minority Business Status also apply to DBE Firms?
Response: The criteria titled, **Minority Business Status** has changed as follows:

d. Minority Business Status and Disadvantaged Business Enterprise

50 Points

Points are pre-populated by the Purchasing Department. If the firm meets both areas, five (5%) percent of the total evaluation points are awarded. If the firm does not meet both areas, zero (0%) percent of the points available are awarded.

Minority Business Status:

A firm, or its sub contractors, is designated as a minority business by the Florida State Office of Supplier Diversity, Department of Management Services.

AND

Disadvantaged Business Enterprise:

- (1) The names and addresses of Disadvantaged Business Enterprise (DBE) firms that will participate in the contract;
- (2) A description of the work that each DBE firm will perform;
- (3) The dollar amount of the participation of each DBE firm listed under (1)
- (4) Written statement from Offeror that attests their commitment to use the DBE firm(s) listed under (1) to meet the Owner's project goal;
- (5) If Offeror cannot meet the advertised project DBE goal; evidence of good faith efforts undertaken by the Offeror as described in appendix A to 49 CFR Part 26.

All other specifications, terms and conditions remain the same.
