

# IMPORTANT INFORMATION

## Pinellas County Utilities FEE SCHEDULE

The Pinellas County Board of County Commissioners, at a public hearing held on September 22, 2009, by Resolution number 09-130, approved changes to the fee schedule for customers of Pinellas County Utilities' services. The fees included in this brochure represent the customer fees for obtaining Pinellas County water, sewer, and reclaimed water services. Except as noted, the fees listed in this brochure are effective for services provided **beginning February 1, 2010.**

The schedule of fees included in this brochure represent the most common fees applicable to customer accounts. This brochure is not inclusive of all fees approved on September 22, 2009. Further, there are other fees not included in this brochure which were effective October 1, 2009.

This fee schedule does not represent the user fees for Pinellas County water, sewer and reclaimed services. The user fees for FY2010 were adopted by separate resolution on September 29, 2009 with an effective date of October 1, 2009. The user fees are available for review on our Web site.

## DEPOSITS

When an account includes both water and sewer services, the deposit amount will be the sum total of the approved amount for each service.

## SERVICE CHARGES

### Water and Reclaimed Services

The charges in this section, where applicable, will be increased 50% for services outside of normal business hours (8am - 5pm), and for all holidays and weekends.

Turn on Fee (scheduled), future date	\$16.00
Turn on Fee, same date	\$32.00
Pre-termination notice	\$18.00
Delinquent turn off	\$21.00
Delinquent turn on, future date	\$19.00
Delinquent turn on, same date	\$32.00
Special meter reading, water already on	\$16.00
Check last reading fee	\$19.00
(if routine or special meter reading was correct)	
Off-cycle reading for billing	\$19.00

## METER RESET & TEST FEES

### Water and Reclaimed Services

Meter test will be conducted by customer request. When meter registers within accuracy range of the calibrated shop test, the customer will be subject to the meter shop test charges based on meter size, in addition to the **Meter reset fee**. The charges in this section, where applicable, will be increased 50% for services outside of normal business hours (8am - 5pm), and for all holidays and weekends.

Meter reset fee, ¾- to 1-inch	\$30.00
Meter reset fee, larger than 2-inch	At cost
Meter test fee in shop, ¾- to 1-inch	\$35.00
Meter test in shop, 1½- to 2-inch	\$45.00
Meter test in field, larger than 2-inch	At cost
Potable fire hydrant flow test	\$75.00

## LATE PAYMENT FEE

A late payment fee will be charged for balances owed (*greater than \$5.00*) that are not received and credited to your account by the **Delinquent After** date on the bill. The late payment fee will be 10% of the charges due with a minimum of \$1.00 up to a maximum of \$500.00. Late payment fees may subject your account to a deposit charge due to delinquency.

## DISHONORED PAYMENT FEE

*In accordance with Sections 125.0105 and 832.08 (5), F.S., a service fee for the collection of a dishonored check, draft, or other order will be charged as follows, whichever is greater:*

### When face value of payment is:

Up to \$50.00	\$25.00
\$50.01 to \$300.00	\$30.00
\$300.01 to \$800.00	\$40.00
More than \$800.00	5% of payment's face value

## FIRE PROTECTION CHARGES

### Standby Charges for unmetered private fire protection facilities

*The following annual charges will be pro-rated over the bi-monthly bills on the customer's account.*

6-inch or less fire line	\$102.00
8-inch fire line	\$174.00
10-inch fire line	\$342.00
12-inch fire line	\$390.00

*Persons desiring to have public fire protection facilities relocated shall pay in advance 100% of the estimated cost of relocation. Upon completion of the project they shall be billed actual cost plus overhead, less the amount advanced.*

## SEWER SYSTEM GREASE PROCESS FEES

### Permit Fee for Food Service Facilities

#### Effective October 1, 2009

With grease interceptor	\$140.00
With a grease trap	\$115.00

#### Effective February 1, 2010

Pumping variance fee	\$200.00
Re-inspection fee	\$50.00
