Name & Address
Customer and account name and billing address.

Meter Number
Serial number of meter serving your account.

Service Address
Address where your utility service is delivered.

Billing Period
Time span between prior and current meter readings (approximately two months).

Days
Number of days in billing period.

Usage History
Water usage for the past year (last 6 bills).

Services Billed
Pinellas County may be billing you on behalf of another agency; if so, contact that agency with questions.

Average Daily Use
Your account's average daily use for the period compared to the average use per person per day. Divide the figure shown by the number of people in your household.

Scheduled Reading Date
Next scheduled date for reading the water meter. Can vary 3-5 days before or after this date.

Deposit on Account
The amount of deposit being held on your account.

Web Payment EZ Pay
To pay your bill online, visit www.pinellascounty.org/utilities (select "EZPay Utility Bill" from "Billing" menu).

Meter Readings
Provides information on which your water charges are based (sewer charges also in some cases).

Prior
Reading obtained from previous meter reading.

Current
Most recent reading obtained from the meter.

Information Message
Special messages concerning water service and other items of interest appear in this space.

Evacuation Level
Hurricane evacuation level based on the service address. For questions, call (727) 464-3800.

Statement Date
The date your bill was issued.

Same Period Last Year
Amount of water (1,000 gallons) used for the same billing period 12 months ago.

Consumption
The amount of water usage (in 1,000 gallons) that registered on your meter for your water (sewer charges also in some cases). This is the difference (in 1,000 gallons) between the current and previous readings.

Return Stub
Separate at the perforation and return bottom portion with your payment or credit card information for proper credit.

Amount Due
Payments received after the delinquent date are subject to a Late Payment Fee (10% of balance due — \$1 minimum, \$500 maximum).

Pay with Visa or MasterCard
Complete the information on this stub to pay by credit card.

Delinquent Date
Your payment is due upon receipt and is delinquent (and subject to a Late Payment Fee) if not received in our office by the date shown.

Account Number
For faster service, please refer to this number when calling Utilities Customer Service.
