I. Meeting Minutes Review and Approval

The group approved the meeting minutes from November 18th, 2014 unanimously.

II. Presentation by Mary Scott Hardwick on Legislative Agendas

The group learned about the numerous priorities of the Pinellas County State Legislature and learned how properly compose a bill. We discussed the possibilities of passing laws on watershed preservation and decided it was a good idea. After considering watershed education, merging with Tampa Bay Watch, hiring Veteran Services Officers, energy policies, park preservation and budget, and working with the Department of Juvenile Justice, the group voted on and ultimately decided on the watershed after four rounds of voting.

III. Watershed Campaign Brainstorming Session with Mary Burrell

The group reviewed last meeting's discussion educating the public through social media and/or a photo contest. Due to the lack of success through public service announcements in St. Pete High, the group agreed to focus on posting a video on Instagram. We were provided with a sample audio for the video to be posted and shared online, changed some of the language to be more teen-friendly, and discussed the prize for the winner of the photo contest (decided on a kayaking tour for six). We also brainstormed on the hashtag "wtrshd" (watershed without vowels) and created a list of people to star in the video.

IV. Review of Lake Seminole Park Community Project

The group had twelve members attend and helped clean and paint four park tables. We ultimately decided that the project was successful and decided on revisiting the park next year.

V. Tallahassee Trip

The group realized that that our limited meetings may not provide enough time to propose legislation to the state and elected Jake to look at dates and decide the costs and/or fundraising to be brought up at the next meeting.
