126        (d) The Board of County Commissioners of Pinellas County  
 127 may remove any member of the board for cause.

128        (9) Notwithstanding any law to the contrary, if the  
 129 qualified electors of Pinellas County voting in a referendum  
 130 approve the transfer of all authority of the board to the Board  
 131 of Commissioners of Pinellas County, the board shall stand  
 132 dissolved as of the effective date of the referendum.

133        Section 2. This act shall take effect upon becoming a law.
